



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE DECEMBER 19, 2009 "CHRISTMAS LIGHTS ON BROADWAY" SPONSORED BY INNER CITY COMMUNITY DEVELOPMENT, CORP., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$790.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 2 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, Inner City Community Development, Corp. has requested in-kind services from the Miami-Dade Park and Recreation Department for the December 19, 2009 "Christmas Lights on Broadway" in an amount not to exceed \$790.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "Christmas Lights on Broadway" event is to provide, among other things, free medical screenings and family-friendly entertainment; and

WHEREAS, Inner City Community Development, Corp. is a not-for-profit organization; and

WHEREAS, the "Christmas Lights on Broadway" is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$790.00 of the in-kind services shall be funded from the unspent balance of the District 2 FY 2008-09 In-kind Reserve Fund,

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Inner City Community Development, Corp., for their "Christmas Lights on Broadway" event held on December 19, 2009.

In-kind services have been requested in an amount not to exceed \$790 from the Miami-Dade Park and Recreation Department for the use of a 24'X40' stage. This event will be funded from the unspent balance of the District 2 FY 2008-09 in-kind reserve fund.

In FY 2009-10, Inner City Community Development, Corp., received \$21,250 from the General Fund to fund elderly services programs.
