### Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

### Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Parker-Harr Charities, Inc., for their "Sammie Jo Day-For a Better Tomorrow" event held on January 31, 2010.

In-kind services have been requested in an amount not to exceed \$2,000 from the Miami-Dade Park and Recreation Department for the use of a medium showmobile. This event will be funded from the unspent balance of the District 8 FY 2008-09 in-kind reserve fund.

In FY 2009-10, Parker-Harr Charities, Inc., received no funding for this event.
