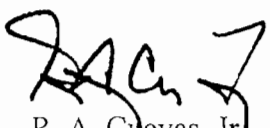

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MARCH 13, 2010 "ST. PATRICK'S DAY FESTIVAL" SPONSORED BY ST. PATRICK'S DAY COMMITTEE, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,500.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 7 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, St. Patrick's Day Committee, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the March 13, 2010 "St. Patrick's Day Festival" in an amount not to exceed \$2,500.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "St. Patrick's Day Festival" is a free event to celebrate the Irish culture and traditions; and

WHEREAS, St. Patrick's Day Committee, Inc. is a not-for-profit organization; and

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, St. Patrick's Day Committee, Inc., for their "St Patrick's Day Festival" event held on March 13, 2010.

In-kind services have been requested in an amount not to exceed \$2,500 from the Miami-Dade Park and Recreation Department for the use of one (1) large show mobile. This event will be funded from the unspent balance of the District 7 FY 2008-09 in-kind reserve fund.

In FY 2009-10, St. Patrick's Day Committee, Inc., received no funding for this event.
