This plat is bounded on the north by approximately SW 250 Terrace, on the east by approximately SW 127 Avenue, on the south by SW 252 Terrace, and on the west by approximately SW 129 Court.

Plat Restrictions

- That SW 252nd Terrace, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

Developer's Obligation

- Paving, drainage, sidewalks, striping, curb, curb and gutter, valley gutter, guardrail, traffic control signs and monumentation. Bonded under bond number 7821 in the amount of \$253,914.00.

RESOLUTION APPROVING THE PLAT OF MIRABELLA, LOCATED IN THE NORTHEAST 1/4 OF SECTION 26, TOWNSHIP 56 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY APPROXIMATELY SW 250 TERRACE, ON THE EAST BY APPROXIMATELY SW 127 AVENUE, ON THE SOUTH BY SW 252 TERRACE, AND ON THE WEST BY APPROXIMATELY SW 129 COURT)

WHEREAS, Yale-Steam Associates Limited Partnership, a District of Columbia limited partnership, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as MIRABELLA, the same being a subdivision of a parcel of land lying and being in the Northeast 1/4 of Section 26, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.
