Subject: Contract Award Recommendation in the Amount of \$971,538.71 between A & A Fonte, Inc. and Miami-Dade County for the People's Transportation Plan (PTP) Project Entitled Old Cutler Road Bike Path Phase I (**Project – CICC 7040-0/07 Request for Price Quotation (RPQ) No. 20090238**) and Authorizing the Use of Charter County Transit Surtax Funds

Recommendation

The attached Contract Award Recommendation for the PTP Old Cutler Road Bike Path Phase I (Project – CICC 7040-0/07 RPQ No. 20090238), in the amount of \$971,538.71, between A & A Fonte, Inc. and Miami-Dade County has been prepared by the Public Works Department (PWD) and is recommended for approval. Proceeds from the Charter County Transit System Sales Surtax (the Surtax) will be used to fund this project, therefore, approval by the Board of County Commissioners (BCC) and Citizens' Independent Transportation Trust (CITT) is required.

Scope

The work to be performed under the life of this contract includes improvements to the Old Cutler Road Bike Path, from SW 216 Street to the Intersection of SW 136 Street and SW 63 Avenue.

Fiscal Impact/Funding Source

The fiscal impact will be approximately \$971,538.71 and will be funded from the Surtax. The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. Specific funding for this project will be allocated from Commission District 8 yearly allocations. The base contract amount is \$792,307.92, but the total allocated amount is \$971,538.71, which is inclusive of the contingency and dedicated allowances.

Delegation of Authority

No additional authority is being requested within the body of this contract.

Track Record/Monitor

A & A Fonte, Inc. is currently performing work for PWD at a superior level as reported by the Project Manager. PWD has reviewed the Office of Capital Improvements (OCI) database and found two (2) awarded construction contracts both from PWD. The referenced database also lists a total of one (1) contractor performance evaluation with an overall performance rating of superior performance (4.0); this being the highest possible rating. The Department of Small Business Development's (SBD) History of Violation's report lists no violations for this contractor.

Following PWD's standard operating procedures, after award of this contract, a pre-construction meeting will be scheduled. Throughout all PTP projects, the responsible staff person in PWD will be the PTP Coordinator, Mr. Frank Aira, P.E. Following completion of the award process, the project will be assigned to Mr. Joaquin Rabassa, P.E., Project Coordinator, for day to day responsibilities.

According to the Florida Department of State, Division of Corporations, A & A Fonte, Inc., Company Principals are: Andres Fonte, Andres C. Fonte, Ron Parmer and Joe Chan and the Company's address is listed as: 12963 West Okeechobee Road, Suite 8, Miami, Florida 33018.

Background

In an effort to carry on the success of the PTP Neighborhood Improvements initiative, PWD continues to take advantage of various contracting mechanisms such as the subject Miscellaneous Construction Contracting (MCC) process available under OCI contract CICC 7040/0/07. Through this process, PWD forwards the Request for Price Quotation (RPQ), by way of facsimile transmission, to a pool of pre-qualified Community Small Business Enterprise (CSBE) contractors for the subject trade. Additionally, PWD advertises the project in the Daily Business Review and all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" link. The project award evaluation is based upon the lowest sum bid submitted by the responsive, responsible bidder for the project.

PWD staff determined that the scope of work for this project qualified for a CSBE set-aside (Levels I, II, and III) designation. Therefore, on December 23, 2009, PWD forwarded an RPQ for the PTP Old Cutler Road Bike Path Phase I Improvements, utilizing the OCI contract CICC 7040-0/07, to a list of 42 pre-qualified firms. A total of 13 firms purchased contract documents and nine (9) firms proffered a bid. On January 25, 2010, A & A Fonte, Inc. proffered the lowest responsive, responsible base bid of \$792,307.92, 30% below the County's cost estimate; the second lowest bidder, R & G Engineering, Inc., proffered a base bid of \$793,036.40, 1% over the lowest bidder; the third lowest bidder, Kailas Corp., proffered a base bid of \$849,738.70, 7% over the second lowest bidder. As a result, on February 3, 2010, PWD issued a recommendation of award for RPQ No. 20090238 to A & A Fonte, Inc., with the stipulation that approval of this project must be obtained from the BCC and the CITT due to guidelines associated with the funding source.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor (including cleaning and preparation), required materials, equipment and tools to perform all operations necessary for improvements to the Old Cutler Road Bike Path. This work includes construction of asphaltic concrete road base and surface; pavement removal; pavement markings; signage; and concrete curb and gutters.

The total RPQ amount is for nine hundred seventy-one thousand five hundred thirty-eight dollars and seventy-one cents (\$971,538.71). This includes a base contract amount of seven hundred ninety-two thousand three hundred seven dollars and ninety-two cents (\$792,307.92), a contingency amount of seventy-nine thousand two hundred thirty dollars and seventy-nine cents (\$79,230.79), and dedicated allowances totaling one hundred thousand dollars and zero cents (\$100,000.00). The contract duration is established as **180-calendar days**. However, the recommendation of award is contingent upon the submission of the required items listed below:
