Subject: Resolution Amending the FY 2008 through FY 2010 Action Plans to Reprogram Multi-Year CDBG and HOME Funds

RECOMMENDATION

It is recommended that the Board of County Commissioners (BCC) authorize the Mayor or Mayor's designee to amend the FY 2008 through FY 2010 Action Plan to recapture and reallocate \$2,528,920 in prior year Community Development Block Grant (CDBG) funds and \$200,000 in Home Investment Partnership Program (HOME) funds. The reallocation of the funds are recommended for projects previously funded in FY 2008, FY 2009 and FY 2010 as indicated in Exhibit A.

All but \$110,270 of the CDBG funds being recaptured currently reside in reserve accounts and are recommended for reallocation in accordance with the processes in place.

SCOPE

Exhibit A includes information on the Commission District location for each project to be allocated CDBG funds; however, the benefits from certain projects may affect more than one Commission District. In some cases, the benefit may be countywide.

FISCAL IMPACT

Approval of this resolution does not create a negative fiscal impact to the County.

A total of \$2,528,920 in multi-year CDBG funds and \$200,000 in HOME funds is being recommended for reallocation from the CDBG Commission District Fund (CDF), CDBG Community Advisory Committee (CAC), and HOME reserve accounts as well as contracts that are ready to be closed out but have remaining funds.

Funds are being reallocated to public facilities, economic development projects and housing programs that serve Neighborhood Revitalization Strategy Areas (NSRAs) and other eligible geographic areas throughout Miami-Dade County. The programming of these funds to activities that achieve their intended goals and objectives within appropriate timeframes reduces the County's risk of having CDBG and HOME funds deobligated by the federal government.

TRACK RECORD/MONITORING

Most of the entities being recommended for the reallocation of CDBG funding have successfully delivered the products and/or services pursuant to their contractual agreements with DHCD. The additional funds will assist in meeting their objective in a timely manner. Others are in the process of completing their projects and the additional funds in this item will assist in meeting their objective in a timely manner.

DHCD through its planners and project managers will work to monitor and manage the projects mentioned above to ensure successful completion and compliance with federal guidelines and County policies.

BACKGROUND

On an annual basis, DHCD recommends the mid-year recapture and reallocation of CDBG, HOME, and other funding sources, as appropriate, from activities that 1) could not be carried out, 2) are completed and have unexpended balances, 3) have expired contracts, or 4) are viable projects that are not ready to expend funds. This item recaptures \$2,418,650 (out of the total \$2,528,920 recommended for recapture) from the CDBG CDF and CAC reserves, dating back to 2008, and reallocates to activities that are: 1) currently in progress 2) public facilities or 3) eligible, but not previously funded. Because the CDBG CDF and CAC funds reside in "reserve" accounts for future allocation(s), the \$2,418,650 is not technically a recapture, but an allocation. This item serves to distribute from the reserve accounts that were set aside for future allocations. The activities receiving the funds are categorized for the most part as Public Facility Improvements.

The reallocation of the CDBG reserves is in response to a letter from the US Department of Housing and Urban Development (US HUD), dated December 21, 2009, and subsequent conversations, in which US HUD expressed concerns regarding the County's unprogrammed CDBG reserves. The letter from US HUD indicated that the FY 2010 Action Plan, which was approved by the BCC on November 4, 2009 through Resolution R-1284-09, had \$1.55 million in unallocated CDBG CDF and CAC reserves. To comply with federal guidelines and avoid not meeting the required spending ratios, staff reviewed the pending reserve accounts and identified potential viable projects for allocation. Accordingly, this item serves as an Amendment to the Action Plans dedicated primarily to address US HUD's concerns over the unallocated reserve accounts.

CDBG Reallocations

In addition to the \$2,418,650 being reallocated from the reserve accounts, \$110,270 is recommended to fund four activities associated with three entities. Three of the recommended activities have received previous allocations and this amendment will fully fund the projects, or fill a funding gap, while the fourth, HOPE, Inc., is the entity that works with the County to report on the impediments to fair housing, as required by US HUD.

Hope, Inc. (\$32,000)

All entitlements receiving federal funds are required to periodically submit a report entitled The Impediments to Fair Housing. The report looks at all factors that impede Miami-Dade residents from fair housing. US HUD strongly recommends that report be updated every five years. Hope, Inc. currently has a contract with Miami-Dade specifically to focus on these issues, but the current allocation and contract do not include the completion of this report. As such, it is recommended these funds be allocated and the scope of their existing contract be expanded to incorporate that they assist the County with the required report. Since these fees are administration costs, the reallocation to HOPE, Inc. will be recaptured from the DHCD's administration allocation.

Business and Technology Development Corporation (\$70,000)

Funds are recommended to cover the pending funding gap of two Business and Technology Development Corporation activities previously funded with CDBG. A portion will be for the "technical assistance to a business incubator activity" (\$50,000) and the remaining amount will fully fund the ADA building rehabilitation activity (\$20,000).

Community Action Agency (\$8,270)


Funds are recommended for the Elderly Residential Energy Conservation program, which provides for minor home rehabilitation activities to low- to moderate-income households throughout Miami-Dade County. This may include, but is not limited to helping eligible elderly families retrofit their homes with energy efficient appliances.

Home Reallocations

Lutheran Services (\$200,000)

The Second Chance Program provides Tenant Based Rental Assistance (TBRA) to youth/adults aging out of foster care. It is anticipated that the current contract will expire by June 2010. These additional funds will ensure the services through the remainder of 2010. While the County currently has contracts with other agencies that support the elderly and/or formerly homeless, this is the only agency that addresses youth transitioning out of foster care. No other agency funds this type of necessary activity.

RESOLUTION AUTHORIZING THE MAYOR TO AMEND THE FY 2010 ACTION PLAN TO REFLECT THE REALLOCATION OF FY 2008, 2009 AND 2010 COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS, IN THE AMOUNT OF \$2,528,920 AND HOME INVESTMENT PARTNERSHIP FUNDS IN THE AMOUNT OF \$200,000, AS INDICATED IN EXHIBIT A; AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXECUTE ALL CONTRACTS, AGREEMENTS AND AMENDMENTS NECESSARY TO CARRY OUT THE ABOVE PROGRAM, AND TO SHIFT FUNDS AND FUNDING SOURCES AWARDED FOR A PROJECT TO ANY NEW ENTITIES CREATED FOR THE PURPOSE OF CARRYING OUT A PROJECT NECESSARY TO CARRY OUT THE ABOVE PROGRAMS; AND AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXERCISE THE CANCELLATION PROVISIONS CONTAINED THEREIN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the Mayor or Mayor's Designee to amend the FY 2010 Action Plan to reflect the reallocation of \$2,528,920 of FY 2008, 2009 and 2010 Community Development Block Grant Funds (CDBG) and \$200,000 of 2010 Home Investment Partnership (HOME) funds as indicated in Exhibit 1 and authorizes the Mayor or Mayor's Designee to execute such contracts, agreements and amendments, as are required, following approval by the County Attorney's Office and subject to proper execution by the parties; to shift funds and funding sources awarded for a project to any new entities created for the purpose of carrying out a project necessary to carry out the above programs; and to exercise the cancellation provisions contained therein.



Minister, wife get jail terms

A minister and his wife - parents of three young children - are heading to prison for their roles in a mortgage-fraud scheme linked to drug proceeds.

A Miami-Dade minister was sentenced Wednesday to 20 years and his wife to 4 1/2 years in prison for their convictions in a \$6 million mortgage scheme fueled by drug money.

Garry and Yvonne Souffrant, both 33, who formerly lived with their three children in Davie, were sentenced in Miami federal court by U.S. District Judge Paul Huck.

The judge found that Garry Souffrant committed perjury during his trial testimony, and that he obstructed justice by tampering with grand jury witnesses in the case.

In November, the couple was convicted of conspiring to defraud major banks to buy 32 residential properties in Miami-Dade, Broward and other parts of Florida during the real-estate boom. Garry Souffrant, former pastor of God First Ministries in Miami Gardens, was also convicted of conspiring to launder drug proceeds.

Souffrant, a former supervisor at Boca Raton Fire Rescue, was also accused of recruiting his brother into the conspiracy. But Miami Fire Rescue Capt. Gamaliel Souffrant, 44, of Pembroke Pines, was acquitted.

Dozens of relatives, friends and others wrote letters of support for Yvonne Souffrant but none for Garry Souffrant, according to court records.

He is already in custody. The judge gave Yvonne Souffrant two weeks to turn herself in, denying her request to postpone her surrender until the end of the school year. Relatives will take in the couple's children.

According to federal authorities, the couple used their family business, Progressive Real Estate of Broward, to help local drug traffickers purchase homes

and luxury automobiles, including a 2004 Rolls-Royce Phantom.

The couple acted as straw buyers for the dealers, concealing the source of their tainted money to purchase the properties. Assistant U.S. Attorney Michael "Pat" Sullivan

said. They also diverted mortgage loans to fund the scheme and their personal expenses.

Sullivan said the conspiracy, investigated by the IRS, FBI and Miami-Dade police, grew out of a probe into a Northwest Miami-Dade cocaine organization.

The drug ring's leaders, Ali Adam and Graylin Kelly, were convicted and sentenced to 30 years in prison.

At the Souffrants' trial, Adam testified that he gave the couple drug profits to buy 12 houses in South Florida.

WESTON Ponzi seam nets 16 years

A Weston man who is going to prison must repay millions of dollars for running what prosecutors say was a Ponzi scheme he used to finance a life of luxury.

A federal judge in Harrisburg, Pa., sentenced Sean Healy on Wednesday to almost 16 years in prison and ordered him to repay almost \$17 million to bilked investors.

Healy, 39, pleaded guilty last year to two counts of wire fraud and one count of unlawful monetary transactions.

Prosecutors say he promised to buy securities for the investors but instead spent the money on a waterfront mansion in Weston, jewelry and exotic sports cars.

Most of the money came from investors in Pennsylvania.

4 women in space – a record

Space shuttle Discovery, with three women onboard, will break a record when it helps put the most women ever in orbit.

CAPE CANAVERAL, Fla. — (AP) — Space is about to have a female population explosion.

One woman already is circling Earth in a Russian capsule, bound for the International Space Station. Early Monday morning, NASA will attempt to launch three more women along with four men — aboard shuttle Discovery.

It will be the most women in space at the same time.

Men still will outnumber the women by more than 2-to-1 aboard the shuttle and station, but that

science in Vancouver, Wash. Indeed, the head of NASA's space operations was unaware of the imminent women-in-space record until a reporter brought it up last week.

But it makes no difference to educator-astronaut Dorothy Metcalf-Lindenburger's 3-year-old daughter Gabriela.

"To her, flying is cool. Running around is being cool. Just learning and growing up as a kid is cool. There aren't a lot of distinctions, and that's how I want it to be," said Metcalf-Lindenburger, 34, who used to teach high school

"Maybe that's a credit to the system, right? That I don't think of it as male or female," said space operations chief Bill Gerstenmaier.

Rounding out the foursome will be Tracy Caldwell Dyson, who was launched aboard a Soyuz rocket from Kazakhstan on Friday with two Russian men. They will arrive Sunday for a six-month stay.
