

RESOLUTION CO-DESIGNATING SW 47 STREET
FROM SW 127 AVENUE TO SW 132 AVENUE AS
“ROYAL BOULEVARD”

WHEREAS, Royal Green Elementary School was built in 1972 with an addition built in 1998 in order to accommodate more students; and

WHEREAS, Royal Green Elementary School has been an “A” school since 2002, providing free tutoring to students that need additional help in their courses; and

WHEREAS, the students of Royal Green Elementary come from different backgrounds and different origins, and despite being a “Title I” school, meaning it is a school with families of low income, the school’s academic achievement is very high; and

WHEREAS, their mascot is a lion named “Royal”, and faculty, staff, students and the PTA want to recognize the achievements of the school by co-designating a portion of SW 47 Street with the mascot’s name; and

WHEREAS, this Board would like to honor the academic achievements of Royal Green Elementary School with this codesignation; and

WHEREAS, SW 47 Street from SW 127 Avenue to SW 132 Avenue is a County road located in unincorporated Miami-Dade County; and

WHEREAS, this proposed codesignation is located in County Commission District 10,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, co-designates SW 47 Street from SW 127 Avenue to SW 132 Avenue as “Royal Boulevard”.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Senator Javier D. Souto. It was offered by offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:


