

RESOLUTION CO-DESIGNATING SW 30 STREET FROM SW 132 AVENUE TO SW 134 AVENUE AS “JACLYN ELISSE TORREALBA STREET”

WHEREAS, Jaclyn Elisse Torrealba was born on June 14, 1991 to Pablo and Vilma Torrealba; and

WHEREAS, Jaclyn was an intelligent, respectful and kind young woman, full of dreams, who graduated in the top 10 percent of her class, was in the National Honor Society and obtained a Bright Futures Scholarship to continue her studies at Florida International University; and

WHEREAS, Jaclyn excelled in arts and sports and dedicated part of her time to help people in need at a community mental health center; and

WHEREAS, Jaclyn’s life was taken on October 11, 2009 at the age of 18, and

WHEREAS, this Board would like to honor the memory of Jaclyn Elisse Torrealba with this codesignation; and

WHEREAS, SW 30 Street from SW 132 Avenue to SW 134 Avenue is a County road located in unincorporated Miami-Dade County; and

WHEREAS, this proposed codesignation is located in County Commission District 11,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, co-designates SW 30 Street from SW 132 Avenue to SW 134 Avenue as “Jaclyn Elisse Torrealba Street”.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the

Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department and the Miami-Dade Fire Rescue Department.


