QUITCLAIM DEED

"This deed constitutes a conveyance from an executive agency of the State of Florida to an agency or instrumentality of the State of Florida and is not subject to documentary stamp tax. See Department of Revenue Rule 12B-4.014 (10), Florida Administrative Code."

THIS QUITCLAIM DEED, made this 9th day of February, 2010, by and between the STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, an executive agency of the State of Florida, whose post office address is Turnpike Headquarters, P.O. Box 613069, Milepost 263, Florida's Turnpike, Building 5315, Ocoee, Florida 34761-3069, as Grantor, and MIAMI-DADE COUNTY, a political subdivision of the State of Florida, whose mailing address is Stephen P. Clark Center, 111 NW First Street, Suite 1610, Miami, Florida 33128-1970, as Grantee. (Wherever used herein the terms Grantor and Grantee shall include the successors and assigns of Grantor and Grantee.)

WITNESSETH

WHEREAS, the land hereinafter described was acquired by the Grantor for state highway purposes; and

WHEREAS, the said land is no longer required by the Grantor for state highway purposes, and the Grantor, by action of the Florida Turnpike Enterprise Executive Director, pursuant to the provisions of Section 337.25, Florida Statutes, has agreed to quitclaim the said land to the Grantee.

NOW THEREFORE, in consideration of the premises and the sum of One Dollar, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor does remise, release and forever quitclaim to the Grantee all right, title and interest of the State of Florida Department of Transportation, in and to the property described in Exhibit "A", attached hereto and made a part hereof, subject to the following terms, conditions and reservations:

1. No commercial transmission or receiving devices which carry signals that could cause interference with the operations of the Grantor may be placed or constructed on the property; this restriction shall run with the land in perpetuity and be binding on all successors in title.

2. The Grantee accepts all responsibility for operation and maintenance of the roadway, including all curbs, culverts, and drainage structures within the right-of-way at the time of transfer.

3. All obligations of the Grantor under any maintenance or utility agreements or other such agreements existing at the time of this conveyance shall become the responsibility of the Grantee.

4. Pursuant to Section 337.25(4)(h), Florida Statutes, the property described in Exhibit "A" will be used by the Grantee for a public purpose.

5. Grantor reserves all rights of ingress, egress, light, air and view between the property described in Exhibit "A" and Grantor's abutting property (SR 821 - Homestead Extension of Florida's Turnpike).

TO HAVE AND TO HOLD the same together with the appurtenances thereunto belonging or in anywise appertaining, and all the estate, right, title and interest of the said Grantor, either in law or equity, to the said Grantee forever.


