

WHEREAS, the Center for Folk and Community Art Deco Echo Artists Delegation, Inc. has requested a cash allocation for the Art Work Shops and Exhibition; and

WHEREAS, the Center for Folk and Community Art Deco Echo Artists Delegation, Inc. is a not-for-profit organization; and





Subject: In-Kind Reserve Cash Allocation Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district in-kind reserve balance allows for the funding of this request.

Background

A cash allocation for in-kind services is being requested by a not-for-profit organization, Center for Folk and Community Art Deco Echo Artists Delegation, Inc., for the "Art Work Shops and Exhibition" event held on June 2, 2010.

In-kind services have been requested through a cash allocation up to an amount not to exceed \$2,500 for the event to be held on June 2, 2010. This event will be funded from the unspent balance of the District 5 FY 2008-09 in-kind reserve fund.

For FY 2009-10, the Center for Folk and Community Art Deco Echo Artists Delegation, Inc., received \$11,938 from the General Fund for programmatic support and \$500 from District 4 office funds.
