

RESOLUTION APPROVING THE STATE CO-DESIGNATION
OF STATE ROAD 997 BETWEEN S.W. 288TH STREET AND
S.W. 344TH STREET AS "JOHN TORRESE FAMILY ROAD"

WHEREAS, during the 2010 regular session, the Florida Legislature passed HB 5 which co-designated State Road 997 between S.W. 288th Street and S.W. 344th Street as "John Torrese Family Road"; and

WHEREAS, State Road 997 between S.W. 288th Street and S.W. 344th Street is a state road located in unincorporated Miami-Dade County; and

WHEREAS, section 334.071, Florida Statutes, provides that the installation of road designation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road designation; and

WHEREAS, this co-designation is located in County Commission District 8,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the state road co-designation of State Road 997 between S.W. 288th Street and S.W. 344th Street as "John Torrese Family Road".

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Secretary of the Florida Department of Transportation and the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department.
