

RESOLUTION APPROVING THE STATE CO-DESIGNATION
OF SW 88 STREET FROM SW 137 AVENUE TO SW 142
AVENUE AS “MANUEL CAPO WAY”

WHEREAS, during the 2010 regular session, the Florida Legislature passed HB 5 and HB 321, both of which designated SW 88 Street from SW 137 Avenue to SW 142 Avenue as “Manuel Capo Way”; and

WHEREAS, section 334.071, Florida Statutes, provides that the installation of road designation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road designation; and

WHEREAS, SW 88 Street from SW 137 Avenue to SW 142 Avenue is a state road located in unincorporated Miami-Dade County; and

WHEREAS, this co-designation is located in County Commission District 11,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the State Legislature co-designation of SW 88 Street from SW 137 Avenue to SW 142 Avenue as “Manuel Capo Way.”

Section 2. Directs the Mayor or Designee to erect signage at all intersections and on all streets, including street signs on mast arms, intersecting SW 88 Street between SW 137 Avenue to SW 142 Avenue identifying this portion of SW 88 Street as “Manuel Capo Way.”

Section 3. Directs the Clerk of the Board to send certified copies of this Resolution to the Secretary of the Florida Department of Transportation and the Traffic Signals and Signs

Division of the Public Works Department and Land Development Division of the Public Works Department.


