RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE APRIL 24, 2010 "MARCH FOR BABIES" SPONSORED BY THE MARCH OF DIMES FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,000.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 11 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, March of Dimes Foundation, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the April 24, 2010 "March for Babies" in an amount not to exceed \$2,000.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "March for Babies" is to raise funds for research and educational outreach to prevent birth defects, premature births and infant mortality; and

WHEREAS, March of Dimes Foundation, Inc. is a not-for-profit organization; and

WHEREAS, the "March for Babies" is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$2,000.00 of the in-kind services shall be funded from the unspent balance of the District 11 FY 2008-09 In-kind Reserve Fund,

Waivers

Any and all waivers of fees or surcharges must be approved by a majority of the Board of County Commissioners members present, and shall be granted only if the Event Organizer can provide evidence that such fees and surcharges exact an undue burden on event guest.

Fee for County Services

The Event Organizer is required to fully reimburse to the Miami-Dade Parks and Recreation Department for any and all costs borne by the Department. If any department staff and/or equipment is required to assist to operate or provide maintenance for an event, the Department shall be compensated for the full cost of providing the support.

Park Improvement Surcharge

The Event Organizer will be responsible for remitting a per patron surcharge, the of which shall be evaluated annually and approved by the Department Director, to be reinvested in the Park and Recreation Facility hosting the Special Event to offset higher than customary deterioration of the facility.





Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, March of Dimes Foundation, Inc., for the "March for Babies" event held on April 24, 2010.

In-kind services have been requested in an amount not to exceed \$2,000 from the Miami-Dade Park and Recreation Department for Crandon Park personnel expenses. This event will be funded from the unspent balance of the District 11 FY 2008-09 in-kind reserve fund.

In FY 2009-10, March of Dimes Foundation, Inc. received \$3,500 from District 4 office funds and \$2,000 from District 10 office funds.
