Subject: Contract Award Recommendation in the Amount of \$1,000,000.00 between H & J Asphalt, Inc. and Miami-Dade County for the People's Transportation Plan (PTP) Project Entitled Roadway Resurfacing Contract – Countywide (**Project – MCC 7360 Plan Request for Price Quotation (RPQ) No. 20100427**) and Authorizing the Use of Charter County Transit Surtax Funds

Recommendation

The attached Contract Award Recommendation for the Roadway Resurfacing Contract – Countywide (Project – MCC 7360 Plan RPQ No. 20100427), in the amount of \$1,000,000.00, between H & J Asphalt, Inc. and Miami-Dade County has been prepared by the Public Works Department (PWD) and is recommended for approval. Proceeds from the Charter County Transit System Sales Surtax (the Surtax) will be used to fund this project, therefore, approval by the Board of County Commissioners (BCC) and Citizens' Independent Transportation Trust (CITT) is required.

Scope

The work to be performed under the life of this contract includes roadway resurfacing at various locations within Miami-Dade County.

Fiscal Impact/Funding Source

The fiscal impact will be approximately \$1,000,000.00 and will be funded from the Surtax. The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. Specific funding for this project will be allocated from the respective Commission District PTP yearly allocations. This is a work order based contract with a base contract amount of \$879,090.00. The total recommended award amount is \$1,000,000.00, which is inclusive of the contingency and dedicated allowances. This project does not create any additional impact on the current budget nor does it impact future budgets.

Delegation of Authority

No additional authority is being requested within the body of this contract.

Track Record/Monitor

H & J Asphalt, Inc. is currently performing work for PWD at a satisfactory level as reported by the Project Manager. PWD has reviewed the Office of Capital Improvements (OCI) database and found 29 awarded construction contracts and are listed as follows: one (1) from the Department of Environmental Resources Management (DERM) and 28 from PWD. The referenced database also lists a total of 61 contractor performance evaluations (several contracts having two (2) evaluations on file, an interim and a project closeout) with an overall performance rating of satisfactory performance (3.0), out of a possible superior performance (4.0) rating.

The Department of Small Business Development's (SBD) History of Violation's report lists three (3) closed violations for this contractor. H & J Asphalt, Inc. is not a registered Community Small Business Enterprise (CSBE) firm.

Following PWD's standard operating procedures, after award of this contract, a pre-construction meeting will be scheduled. Throughout all PTP projects, the responsible staff person in PWD will be the PTP Coordinator, Mr. Frank Aira, P.E. Following completion of the award process, the project will be assigned to Mr. Joaquin Rabassa, P.E., Project Coordinator, for day to day responsibilities.

According to the Florida Department of State, Division of Corporations, H & J Asphalt, Inc., Company Principals are: Humberto Lorenzo and Jorge Lorenzo and the Company's address is listed as: 4310 NW 35 Avenue, Miami, Florida 33142.


Background

In an effort to carry on the success of the PTP Neighborhood Improvements initiative, PWD continues to take advantage of various contracting mechanisms such as the subject Miscellaneous Construction Contracting (MCC) process available under OCI contract MCC 7360 Plan. Through this process, PWD forwards the Request for Proposal Quotation (RPQ), by way of facsimile transmission, to a pool of firms that have registered with OCI for the subject trade. Additionally, PWD advertises the project in the Daily Business Review and all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" link. Interested contractors prepare their bids according to the Job Order Contracting (JOC) process, whereby the County establishes unit prices for the pay items in accordance with industry averages. The contractors submit their bid as an overall percentage factor of the pricing established by the County. The project award evaluation is based upon the lowest percentage submitted by the responsive, responsible bidder for the project.

PWD staff submitted the referenced project to the SBD Review Committee. The Review Committee met on March 31, 2010 reviewed RPQ No. 20100427 and recommended a 10% overall CSBE subcontractor goal based on the project's scope of work and cost estimate of \$1,000,000.00. Therefore, on March 12, 2010, PWD forwarded an RPQ for the Roadway Resurfacing Contract, utilizing the OCI contract MCC 7360 Plan, to a list of 76 pre-registered firms. A total of 10 firms purchased contract documents and 5 firms proffered a bid.

On May 5, 2010, H & J Asphalt, Inc. proffered the lowest responsive, responsible base bid of 0.83 percentage factor, 17% below the County's cost estimate; the second lowest bidder, General Asphalt Co., Inc., proffered a base bid of 0.89 percentage factor, 6% over the lowest bidder; the third lowest bidder, H & R Paving, Inc. proffered a base bid of 0.90 percentage factor, 1% over the second lowest bidder. As a result, on May 10, 2010, PWD issued a recommendation of award for RPQ No. 20100427 to H & J Asphalt, Inc., with the stipulation that approval of this project must be obtained from the BCC and the CITT due to guidelines associated with the funding source.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, equipment and tools to perform all operations necessary for roadway resurfacing improvements. The work includes clearing and excavating of shoulder areas or build-up, grading and clean-up of adjacent shoulders and removal of roots, if required. Additional work to be performed includes milling of existing pavement, resurfacing of the full roadway, the widening and resurfacing of intersecting streets, resurfacing of asphalt pathways (pedestrian, bicycle, etc.) adjacent or not to edge of pavement, if necessary.







This includes a base contract amount of eight hundred seventy-nine thousand ninety dollars and zero cents (\$879,090.00), a contingency amount of eighty-seven thousand nine hundred nine dollars and zero cents (\$87,909.00), and dedicated allowances totaling thirty-three thousand one dollar and zero cents (\$33,001.00). The contract duration is established as **365-calendar days**. However, the recommendation of award is contingent upon the submission of the required items listed below:

1. Performance and Payment Bond as required in Contract No. MCC 7360 Plan, Section 2.0 Special Conditions, Page 16, Article 2.11, **PERFORMANCE AND PAYMENT BOND**. (The **original attached documents** must be used and three (3) copies must be provided).

Upon obtaining the permit(s), a copy(s) must be submitted to the Project Manager prior to commencement of work.

No work is to be performed without a permit unless the Project Manager issues a written directive to proceed without permit(s). After receipt of the permits the Project Manager will

schedule a Pre-Construction Conference and issue a Notice to Proceed authorizing the performance of the work. This letter will also serve as a reminder that all work must be performed according to the scope of work and contract's terms and conditions, all permits and inspections and in accordance with all applicable Federal, State and local laws, codes and regulations.

Additionally, this contract, along with any future contracts awarded to your firm, have very similar completion schedules and competing deadlines. Please be advised that your firm must have the resources to ensure work proceeds without delay once the "Notice to Proceed" is issued. This will result in your firm working on multiple contracts concurrently. Lack of equipment and/or personnel will not be reason for delay.

Further, it shall be understood that since proceeds from the Charter County Transit System Sales Surtax levied pursuant to Section 29.121 of the Code of Miami-Dade County may be used to pay for all or some part of the cost of this contract, no award of this contract shall be effective and thereby give rise to a contractual relationship with the County unless and until the following have occurred: 1) the County Commission awards the contract, and such award becomes final (either by expiration of 10 days after such award without veto by the Mayor, or by Commission override of a veto); and 2) either i) the Citizens' Independent Transportation Trust (CITT) has approved same, or ii) in response to the CITT's disapproval, the County Commission re-affirms its award by two-thirds (2/3) vote of the Commission's membership and such reaffirmation becomes final.


