RESOLUTION NO. 2010-27406

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, URGING THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS TO INCREASE THE FINE FOR VEHICLES ILLEGALLY PARKED IN BUS STOPS AND IN TAXI-CAB STANDS FROM \$23.00 TO \$100.00 PER VIOLATION.

WHEREAS, bus stops and taxi-cab stands provide a valuable and necessary function by facilitating the safe loading and unloading of passengers that utilize these transportation services in Miami-Dade County; and

WHEREAS, when a person is illegally stopped or parked in a bus stop or taxi-cab stand, it interferes with the orderly provision of transportation services, impedes traffic flow, and creates unsafe traffic conditions; and


WHEREAS, the current penalties for the violation of illegal parking in bus stops or taxi-cab stands in Miami-Dade County is currently \$23.00, which is an insufficient penalty given the gravity of these types of violations; and

WHEREAS, the Mayor and City Commission deem it to be in the best interest of the public health, safety, and welfare to discourage illegal parking in bus stops and taxi-cab stands, as prohibited in Section 30-388.27 of the Miami-Dade County Code, and hereby urge the Miami-Dade County Board of County Commissioners to increase the fine for these offenses from \$23.00 to \$100.00 per violation.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Board of County Commissioners for Miami-Dade County is hereby urged to increase the fine for illegal parking in bus stops and taxi-cab stands from \$23.00 to \$100.00 per violation.


