

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARK AND RECREATION DEPARTMENT FOR THE JULY 24, 2010 "ANNUAL GOSPEL YOUTH EXPLOSION," SPONSORED BY EBENEZER UNITED METHODIST CHURCH, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$2,000.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF DISTRICT 3 FY 2008-09 IN-KIND RESERVE FUND



Subject: District Specific In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Ebenezer United Methodist Church Inc., for their "Annual Gospel Youth Explosion" event held on July 24, 2010.

In-kind services have been requested in an amount not to exceed \$2,000.00 from the Miami-Dade Park and Recreation Department for the use of a medium show mobile. This event will be funded from the unspent balance of District 3 FY 2008-09 in-kind reserve fund.

In FY 2009-10, Ebenezer United Methodist Church Inc. received \$1,000 from District 3 discretionary reserve fund.
