Chairman Souto called the meeting to order at 2:17 p.m. and informed everyone that the Committee would consider the non-action agenda items until a quorum was present.

Upon the attainment of a quorum at 2:40 p.m., the Committee proceeded to consider action items on today's (9/13) agenda.

Assistant County Attorney Monica Rizo advised the Committee that Board of County Commissioners (BCC) Chairman Dennis C. Moss, the sponsor, requested deferral of Agenda Item 2B to the next Committee meeting scheduled for October 8, 2010, at 2:00 p.m.

It was moved by Commissioner Heyman that the Committee approve the changes requested by the County Manager in his memorandum dated September 13, 2010, entitled, "Requested Changes to the Recreation, Culture & Tourism Committee Agenda" and the additional change noted by Assistant County Attorney Rizo. This motion was seconded by Commissioner Sorenson, and upon being put to a vote, passed by a vote of 4-0 (Commissioners Jordan and Sosa were absent).

BILL TALBERT, PRESIDENT & CEO, GREATER MIAMI CONVENTION & VISITORS BUREAU RE: TOURISM REVENUE, FORECAST OF TOURISM REVENUE AND THE ECONOMIC IMPACT OF TOURISM REVENUE

Presented

Report: *Assistant County Attorney Monica Rizo read the foregoing special presentation into the record.*

Mr. William "Bill" Talbert, President and Chief Executive Officer, Greater Miami Convention and Visitors Bureau (GMCVB), appeared before the Committee and presented the foregoing item regarding the tourism revenue, forecast of tourism revenue and the economic impact of tourism revenue. He noted that Miami-Dade County was doing well, along with New York City, Chicago, Philadelphia, Boston, Atlanta, Washington and all of the 10 top cities that feed this great county and provide tourist to this community. He commended the County for the opening of the sky train at the Miami International Airport North Terminal on Wednesday, September 15, 2010.

Mr. Talbert informed the Committee members following a meeting that occurred with Governor Charlie Crist regarding the Gulf of Mexico oil spill the County received funding to provide a geography lesson that the oil spill occurred in the Gulf while the City of Miami and Miami-Dade County were located on the Atlantic Coast of Florida. He indicated that he traveled to England, Germany, Brazil, and Argentina very aggressively because the \$1.25 million given to GMCVB funded the marketing and public relations services and had to be spent by August 15th.

Mr. Talbert stated that the tourism numbers continued to grow from all of the County's feeder markets. He indicated that one of the reasons for the growth was the County's support of the Miami-Dade Marketing Initiative for the second year, which was a partnership among Miami-Dade County, Beacon Council, American Airlines, GMCVB, Port of Miami, Miami International Airport, the Downtown Development Authority and Baptist Health of South Florida. He indicated if the County operated the Marketing Initiative, \$4.5 million would be allocated to Miami. He stated that compared to the critical markets in Brazil, Germany, Canada and New York, Miami was a great community to live, work and play. He

Report: *Assistant County Attorney Monica Rizo read the foregoing item into the record.*

County Mayor Carlos Alvarez informed the Committee that the Office of Capital Improvements (OCI) had been working with the Architecture, Construction and Engineering (ACE) Mentor Program for architectural, construction manager and engineering students. He noted that Silvia Lopez, OCI Architect Manager, assisted the students with putting together a simulated design project for a performing arts center. Mayor Alvarez congratulated the students and wished them well in their future endeavors.

The ACE Mentor Program students appeared before the Committee and gave a PowerPoint presentation of the following areas of the simulated project for a performing arts school in Miami:

Ms. Kiara Cuevas introduced the students who were present and informed the Committee of the ACE Mentor Program's mission for its simulated performing arts school project.

Ms. Nona Lee presented the design and concept ideas for the performing arts school.

Ms. Antoina presented the theater design and structure for the performing arts school.

Mr. Alan Gauntlet (phonetic) explained the aspects of sustainability and green building for the project.

Mr. Kevin Rojas presented the construction schedule including site-specific construction challenges and site safety for the project.

Mr. George Navarrete, OCI Director, acknowledged the chaperones who accompanied the students to today's (9/13) meeting. He also expressed a desire to offer the students future jobs in the Department.

101933 Special Presentation**SPECIAL PRESENTATION RE: NATIONAL CHILDHOOD OBESITY AWARENESS MONTH (County Manager) *Presented*****Report:** *Assistant County Attorney Monica Rizo read the foregoing item into the record.*

Mr. Jack Kardys, Director, Miami-Dade Park and Recreation Department, appeared before the Committee, and presented the foregoing Special Presentation regarding National Childhood Obesity Awareness Month. He noted that the United States (U.S.) Congress passed resolutions to raise public awareness and to mobilize the country to address childhood obesity. Mr. Kardys stated the U.S. Congress recognized that prevention was instrumental in making sure that kids grow up healthy and defer some health costs in the future. Mr. Kardys stated the President of the United States (U.S.) issued a proclamation calling on Federal, State and Local governments and all citizens of the U.S. to observe this month as "Childhood Obesity Awareness Month." He stated this month would promote appropriate programs and activities with the goal of promoting healthy eating, physical activities and increasing awareness of childhood obesity among individuals of all ages and lifestyles. He made the Committee members aware that for the past four decades, obesity rates soared among all age groups and increased more than four-fold in children between the ages of six and eleven. Mr. Kardys pointed out that 32 percent (approximately 23 million) of children and teens ages 2 to 19, are obese or overweight, which was considered an epidemic in this country. He indicated significant disparities existed among the race and poverty levels. Mr. Kardys pointed out that financial implications of childhood obesity posed tremendous financial threat for the economy and healthcare systems carrying over \$14 billion per year in direct healthcare costs; therefore, people in the United States spent about 9 percent of their total medical cost on obesity related illnesses. Mr. Kardys stated that obese youth have an 80 percent chance of being obese adults; therefore, more at risk for heart disease, type II diabetes, sleep apnea, stroke and some forms of cancer.

Mr. Kardys stated the Park and Recreation Department (PRD), with the County Commission's support, was doing what it could to combat

childhood obesity. He noted that in 2008, the County Commission adopted the PRD Open Space Master Plan. He stated it was ultimately about recreation and that there were well over 500 miles of trails and bicycle paths planned in this community. Mr. Kardys pointed out that this would greatly enhance the ability of people to have alternative modes of transportation and to get more exercise, whether it was by riding or walking. He thanked the County Commission, the County Mayor, the County Manager, the Office of Strategic Business Management and the Department of Housing and Community Development for the approximately \$732,000 received in the Community Development Block Grant funding that kept the PRD's Out-of-School Program for the kids in this community. He stated that a combination of the following funding resources were operating recreational programs in this community: the CDBG, the Children's Trust, the YMCA, the Boys and Girls Club, the Dade Sports Foundation, fee-based programs, community-based organization (CBO) partners and other funding agencies.

Mr. Kardys informed the Committee members of the PRD program called SPARK (Sports, Play and Active Recreation for Kids), an evidence-based, outcome-oriented active recreational component of the Out-of-School Program. He stated that this program would track key health indicators in children such as Body Mass Index (BMI), pulse, and blood pressure, to show how they progressed in the program. He noted the children go through a fitness challenge and set a series of benchmarks for themselves, including a nutritional training through the Empower Me for Life Program. Mr. Kardys stated that there were over 40 fitness and wellness programs, including boot camps, karate classes, Pilate classes, tennis lessons, rugby, and soccer leagues for adults to take advantage of.

Commissioner Sorenson commended Mr. Kardys on the SPARK program and making it a priority for this community.

POSSIBLE CLOSURE OF THE MIAMI DADE
AUDITORIUM*Presented*

Report: *Assistant County Attorney Monica Rizo read the foregoing item into the record.*

Mr. Jack Kardys, Director, Miami-Dade Park and Recreation Department, noted the misinformation regarding the closure of the Miami Dade Auditorium. He stated that the Auditorium was not closing nor slated for closure or given away to any private company to operate. He informed the Committee members of the issuance of a Request for Proposal (RFP) that would initiate negotiations with a provider to operate the Auditorium. Mr. Kardys stated after the Grand Opera moved away to the Adrienne Arsht Performing Arts Center, it created a big hole in the budget for the Auditorium. In addition, he pointed out the Department had not recovered its revenue stream since the Grand Opera who was the number one tenant left the Auditorium. He stated that it cost approximately \$1 million to operate the Auditorium and the County made about \$560,000 in revenue; however, this year the County would need to subsidize operations costs in the approximate amount of \$447,000.

Mr. Kardys informed the Committee that the Department received an unsolicited proposal over a year and half ago. He stated it was determined that the unsolicited proposal did not adhere to the procedures outlined in County Ordinance No. 08-79; therefore, an RFP to operate the Auditorium was issued. Mr. Kardys stated the RFP's scope for the leasing and operation required that the facility be operated as a Hispanic Cultural Arts and Entertainment venue with the focus on serving the not-for-profit community arts groups along with for-profit entertainment activities and events. Mr. Kardys stated the intent of the County was to make any transition of management seamless and beneficial to the arts and cultural community for County residents. He indicated that the Department would ensure that any partnerships honored booked commitments and current market performance fees, especially for local production companies doing community theatre, including access of all groups in the same way currently conducted by the County. Therefore, he stated, it would be the Department's intent to retain the fees

at the same level for the Auditorium and for the County Commission to continue exercising its authority in approving fee changes at the Auditorium. He indicated that the Department planned to continue move ahead with the RFP evaluation process for the lease, management and operation of the Auditorium, and award of a contract with one County staff member as a liaison. Mr. Kardys stated that this staff member would monitor the Auditorium. He noted he met with the Friends of the Miami Dade Auditorium to assure them a place at the table and encourage their continued efforts for the Auditorium.

Chairman Souto thanked Miami-Dade Park and Recreation Director Jack Kardys for all his work conducted on behalf of Miami-Dade County Auditorium. He stated the Auditorium was a jewel and a famous place for Miami-Dade County Latin community. He noted he received a number of telephone inquiries and visits from constituents regarding the status of the Auditorium. He stated this matter was very important and that it was crucial that the County Administration review this matter closely.

Chairman Souto suggested the Parks and Recreation Director schedule a workshop or forms a group such as an advisory board to conduct an in-depth analysis of the issues and come up with alternatives to closing the Miami-Dade County Auditorium ("Auditorium"). In addition, he suggested funding be identified for the Auditorium.

Commissioner Sosa agreed and supported the review of alternatives for the Auditorium as suggested by Chairman Souto. She indicated Mr. Michael Spring, Director, Cultural Affairs Department, should be involved in this effort.

Commissioner Barreiro expressed his view that it was important for the County Administration to consult with the rental companies that used the Auditorium in the past to determine the plans for the Auditorium. He asked that the County not secure the Auditorium's future on the backs of those companies.

Chairman Souto suggested that the County form a collaborative effort with all other interested parties to save the Auditorium. He suggested that Assistant County Manager Alex Munoz work with Commissioner Gimenez and any other commissioners wishing to participate; the Parks and Recreation Director, the Cultural Affairs

Department Director and people who have used the Auditorium to come up with creative ideas to save the Auditorium.

Commissioner Souto explained that the intent of the foregoing proposed resolution was the elimination of weekend parking fees at certain parks.

Commissioner Sosa expressed concern in that families already paid taxes dedicated for parks.

Commissioner Heyman noted this proposed resolution was an effort to balance the budget. She asked the Park and Recreation Department (PRD) Director if this proposal was in response to the County Commission's plea for the Department to minimize layoffs and closure of parks.

A discussion ensued between Commissioner Heyman and Mr. Kardys regarding the adverse impact to the PRD's revenue stream from the elimination of the weekend parking fees at certain parks.

Commissioner Sorenson stated that a portion of County taxes should take care of parks. She noted that PRD planned to eliminate 20 positions in the approximate amount of \$500,000 that would be a budget cut in the Department's budget. She noted that currently there was a recommendation for the cut of 94 positions within the Department if the rollback budget passed; therefore, this proposal would be additional cuts in positions for this Department.

Commissioner Sorenson expressed her opposition to this proposed resolution because there were too many exceptions.

Hearing no further questions or comments, the Committee forwarded this proposed resolution as presented.
