## Recommendation

This Recommendation to Award Construction Contract No. 20090024 has been prepared by the Public Works Department (PWD) and is recommended for approval.

## Scope

**PROJECT NAME:** PTP Construction of NW 138 Street Bridge over the Miami River Canal

**PROJECT DESCRIPTION:** The work to be performed under this contract consists of, but is not limited to, furnishing of all supervision, labor, required materials, tools, equipment and performing all operations required to construct the work in accordance with the Contract Documents. The project consists of replacing the existing bridge with a new and wider bridge at NW 138 Street over the Miami River Canal; widening of NW 138 Street from two (2) to four (4) lanes from Okeechobee Road to NW 113 Avenue. Work also includes a striped median with a center left turn lane, sidewalks, a continuous storm drainage system, roadway lighting, signalization, pavement markings and signage.

Turn lane improvements and replacement of the existing signal at the intersection of Okeechobee Road and NW 138 Street has been incorporated into this project at the request of Florida Department of Transportation (FDOT).

**FUNDING SOURCE:** PTP revenues, including but not limited to the Charter County Transportation Surtax funds. This site-specific project is included in the PTP Ordinance under the Board Requested Projects in Commission District 12. Any other applicable funding sources may subsidize this contract.

A Joint Participation Agreement (JPA) between Miami-Dade County and FDOT in the amount of \$113,202.00 has been approved (R-504-08) to fund construction of intersection and drainage improvements at Okeechobee Road/ SR 25 and NW 138 Street.

**OPERATIONS COST IMPACT / FUNDING:** The annual operations cost impact for the roadway portion of the work is approximately \$4,664.00 and will be funded through the Department's General Fund allocation. There is no annual operations cost impact for the bridge since it is a fixed bridge.

**EXPLANATION:** This project was advertised on May 28, 2010 and on July 14, 2010, eleven engineering contractor firms proffered bids for the referenced project. The apparent lowest bidder, Weekley Asphalt Paving, Inc., was found Non-Responsive. The firm failed to submit a goal deficit make-up plan at the time of bid submittal as required pursuant to Ordinance No. 09-41 amending the Community Small Business Enterprise (CSBE) program, §10-33-02 of the Code of Miami-Dade County.

The three (3) lowest responsive and responsible bids were as follows: the lowest bidder, Williams Paving Co., Inc., proffered a base bid of \$2,749,528.50, 46% below the County's base estimate; the second lowest bidder, Community Asphalt Corporation, proffered a base bid of \$2,782,806.80, 1% over the lowest bidder; the third lowest bidder, Acosta Tractors, Inc., proffered a base bid of \$2,863,984.70, 4% over the second lowest bidder.

The Office of Capital Improvements (OCI) database lists seven (7) awarded contracts to Williams Paving Co., Inc., and ten (10) contractor performance evaluations with an overall performance rating of satisfactory performance (3.2), out of a possible superior performance (4.0) rating.

As such, PWD recommends that Williams Paving Co., Inc., the lowest responsive, responsible bidder, be awarded the subject contract for the sum of \$3,103,781.35.

Following PWD's standard operating procedures, after award of this contract, a pre-construction meeting will be scheduled. The project will be assigned to Mr. Juan Paan, P.E., Project Coordinator for day to day responsibilities.





**Background**

**BACKGROUND:**

This is a roadway improvement project that was requested by the Board of County Commissioners (Board) for inclusion in the PTP. The existing NW 138 Street Bridge over the Miami Canal has structural deficiencies and needs to be replaced. The replacement bridge will be wider to address the increasing volumes of traffic and additional development anticipated in the western portion of the Town of Medley. The project will also improve traffic operations and safety. There is a JPA currently in place with FDOT to implement proposed improvements along Okeechobee Road and the intersection of NW 138 Street in conjunction with this project.

**RECOMMENDATION**

It is recommended that the Board of County Commissioners (BCC) approve the attached resolution authorizing execution of a Joint Participation Agreement (JPA) between Miami-Dade County and the Florida Department of Transportation (FDOT) for the construction of intersection and drainage improvements at Okeechobee Road/ SR 25 and NW 138 Street.

**SCOPE**

This project is located within the Town of Medley, in Commission District 12.

**FISCAL IMPACT/FUNDING SOURCE**

The total construction costs for the improvements requested by FDOT are estimated at \$113,202. FDOT has drafted design plans for the aforementioned improvements and will provide these to the County. These will be incorporated into the pending Miami-Dade County Public Works Department (PWD) Project No. 20030191, and made a part of the final design plans.

**DELEGATION OF AUTHORITY**

No additional authority is being requested within the body of this contract.

**TRACK RECORD/MONITOR**

FDOT will utilize the resources of the County to contract, construct and administer these improvements on a reimbursable basis. Disbursement of FDOT funds to the County shall be based upon County invoices with certified copies of paid contractor estimates. The project will be assigned to Mr. Bassam Moubayed, CFM, Chief, Construction Division, who will oversee inspections conducted by PWD.

**BACKGROUND**

The existing NW 138 Street Bridge over the Miami Canal has structural deficiencies and needs to be replaced. The replacement bridge will be wider to address the increasing volumes of traffic and additional development anticipated in the western portion of the Town of Medley. In addition, NW 138 Street will be widened from two (2) to four (4) lanes from Okeechobee Road to NW 113 Avenue, including a painted median, sidewalks, storm drainage, roadway lighting, signalization, pavement markings and signing.

FDOT has approached the County to include extending the existing left-turn lane on the eastbound approach of Okeechobee Road to NW 138 Street, and drainage improvements to the pending bridge replacement project. This coordination between FDOT and PWD will minimize duplication of efforts by using the County's contractor to construct the improvements, and will result in causing the least disruption to traffic in the area.

This JPA provides for the construction of these intersection and drainage improvements by the County on behalf of FDOT for an amount of \$113,202.

The County will implement a Public Involvement Plan (PIP) during the construction of the project to provide information to property owners, tenants, and area residents for major work to be performed in the area. The project is anticipated to begin construction in February 2009.



JOINT PARTICIPATION AGREEMENT  
BETWEEN  
STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION  
AND  
MIAMI-DADE COUNTY

THIS AGREEMENT is made and entered into this 13<sup>th</sup> day of June, 2008, between the State of Florida Department of Transportation, a component agency of the State of Florida, hereinafter referred to as the 'DEPARTMENT', and Miami-Dade County, a political subdivision of the State of Florida, acting by and through its Public Works Department, hereinafter referred to as the 'COUNTY'.

RECITALS:

WHEREAS, the DEPARTMENT has jurisdiction over and maintains the State Road (SR) 25 corridor (Okeechobee Road) in Miami-Dade County; and

WHEREAS, the DEPARTMENT has drafted design plans for intersection improvements on SR 25 at NW 138 Street, hereinafter referred to as the 'PROJECT', the individual elements of which are outlined in the attached Exhibit "A", 'Scope of Services', which is herein incorporated by reference; and

WHEREAS, the DEPARTMENT has programmed funding for the PROJECT under Financial Project Number 416423-3-58-01, and has agreed to reimburse the COUNTY for eligible PROJECT costs up to a maximum limiting amount, as outlined in the attached Exhibit "B", 'Financial Summary', which is herein incorporated by reference; and

WHEREAS, the COUNTY has agreed to supervise and inspect all aspects of PROJECT construction and administration; and

WHEREAS, the parties hereto mutually recognize the need for entering into an Agreement designating and setting forth the responsibilities of each party; and

WHEREAS, the parties are authorized to enter into this Agreement pursuant to Section 339.08(e) and 339.12, *Florida Statutes*;

NOW, THEREFORE, in consideration of the premises, the mutual covenants and other valuable considerations contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

## 1. INCORPORATION OF RECITALS

The foregoing recitals are true and correct and are incorporated into the body of this Agreement, as if fully set forth herein.

## 2. GENERAL REQUIREMENTS

- a. The COUNTY shall submit this Agreement to its COUNTY Commission for ratification or approval by resolution. A copy of said resolution is attached hereto as Exhibit "C", 'Resolution', and is herein incorporated by reference.
- b. The COUNTY shall advertise for bid, let the construction contract, administer, supervise and inspect all aspects of PROJECT construction until completion, and, as further defined in Exhibit "A", 'Scope of Services'. The COUNTY shall complete the PROJECT on or before February 28, 2010. All aspects of PROJECT construction and administration are subject to DEPARTMENT standards and specifications and must be in compliance with all governing laws and ordinances.
- c. The DEPARTMENT shall reimburse the COUNTY for eligible PROJECT costs as defined in Exhibit "B", 'Financial Summary', and in accordance with the financial provisions in Section 3 of this Agreement.

## 3. FINANCIAL PROVISIONS

- a. Eligible PROJECT costs may not exceed ONE HUNDRED THIRTEEN THOUSAND TWO HUNDRED TWO DOLLARS (\$113,202.00), as outlined in Exhibit "B", 'Financial Summary'. If additional funding is required, contingent upon DEPARTMENT approval, a supplemental agreement between the DEPARTMENT and the COUNTY authorizing the additional funding shall be executed prior to such costs being incurred.
- b. The DEPARTMENT agrees to pay the COUNTY for the herein described services at a compensation as detailed in this Agreement.
- c. Payment shall be made only after receipt and approval of goods and services unless advance payments are authorized by the State Comptroller under Section 215.422(14), Florida Statutes, or by the Department's Comptroller under Section 334.044(29), Florida Statutes.
- d. Bills for fees or other compensation for services or expenses shall be submitted in detail sufficient for a proper preaudit and postaudit thereof.
- e. Travel costs will not be reimbursed.

- f. Records of costs incurred under the terms of this Agreement shall be maintained and made available upon request to the DEPARTMENT at all times during the period of this Agreement and for three years after final payment is made. Copies of these documents and records shall be furnished to the DEPARTMENT upon request. Records of costs incurred includes the COUNTY's general accounting records and the project records, together with supporting documents and records, of the contractor and all subcontractors performing work on the project, and all other records of the contractor and subcontractors considered necessary by the DEPARTMENT for a proper audit of costs.
- g. Nothing in this Agreement shall be construed to violate the provisions of Section 339.135 (6) (a), Florida Statutes, which provides as follows:

The DEPARTMENT, during any fiscal year, shall not expend money, incur any liability, or enter into any contract which, by its terms, involves the expenditure of money in excess of the amounts budgeted as available for expenditure during such fiscal year. Any contract, verbal or written, made in violation of this subsection is null and void, and no money may be paid on such contract. The DEPARTMENT shall require a statement from the Comptroller of the DEPARTMENT that such funds are available prior to entering into any such contract or other binding commitment of funds. Nothing herein contained shall prevent the making of contracts for periods exceeding one year, but any contract so made shall be executory only for the value of the services to be rendered or agreed to be paid for in succeeding fiscal years; and this paragraph shall be incorporated verbatim in all contracts of the DEPARTMENT which are for an amount in excess of TWENTY FIVE THOUSAND DOLLARS (\$25,000.00) and which have a term for a period of more than one year.

- h. The DEPARTMENT's obligation to pay is contingent upon an annual appropriation by the Florida Legislature.

#### 4. INDEMNIFICATION

To the extent permitted by **Section 768.28, Florida Statutes**, the parties agree to indemnify each other for liability due to any act or omission, neglect or wrongdoing of a party or any of its officers, agents or employees. Further, the parties agree to defend each other against any and all such claims or demands which may be claimed and have arisen as a result of or in connection with the parties' participation in this Agreement. Nothing contained herein shall be construed to contradict the provisions of **Section 768.28, Florida Statutes**, nor shall this Section be construed to require either party to indemnify the other for the negligent acts of the other.

5. GOVERNING LAW

This Agreement shall be governed and construed in accordance with the laws of the State of Florida.

6. AMENDMENT

This Agreement may be amended by mutual agreement of the DEPARTMENT and the COUNTY expressed in writing, executed and delivered by each party.

7. INVALIDITY

If any part of this Agreement shall be determined to be invalid or unenforceable, the remainder of this Agreement shall not be affected thereby, if such remainder continues to conform to the terms and requirements of applicable law.

8. COMMUNICATIONS

- a. All notices, requests, demands, consents, approvals and other communications which are required to be served or given hereunder, shall be in writing and hand-delivered or sent by either registered or certified U.S. mail, return receipt requested, postage prepaid, addressed to the party to receive such notices as follows:

10. FINAL INVOICE

The COUNTY must submit the final invoice on this PROJECT to the DEPARTMENT no later than 120 days after the expiration of this Agreement (June 30, 2010). Invoices submitted after June 30, 2010, will not be paid.

11. ENTIRE AGREEMENT

This Joint Participation Agreement is the entire Agreement between the parties hereto, and it may be modified or amended only by mutual consent of the parties in writing.


