

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE OCTOBER 16, 2010 "HISPANIC HERITAGE NIGHT" SPONSORED BY GLADEVIEW BAPTIST CHURCH OF MIAMI, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,570 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 11 IN-KIND RESERVE FUND

**WHEREAS**, Gladeview Baptist Church of Miami, Inc. is a not-for-profit organization; and

**WHEREAS**, the "Hispanic Heritage Night" is a district event, as defined in the attached Fee Waiver/In-kind Service Application, and \$4,570 of the in-kind services shall be funded from the unspent balance of the District 11 In-kind Reserve Fund,







## Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Gladeview Baptist Church of Miami, Inc., for their "Hispanic Heritage Night" held on October 16, 2010.

In-kind services have been requested in an amount not to exceed \$4,570 from the Miami-Dade Park and Recreation Department for use of one (1) show mobile, tower lights and a sound system. This event will be funded from the unspent balance of the District 11 in-kind reserve fund.

In FY 2010-11, Gladeview Baptist Church of Miami, Inc. received no funding for this event.
