

RESOLUTION URGING THE MAYOR OR DESIGNEE TO
STUDY THE FEASIBILITY OF DEVELOPING
PROGRAMMING FOR BROADCAST ON MIAMI-DADE TV
THAT HIGHLIGHTS THE WORK BEING PERFORMED BY
VARIOUS COUNTY DEPARTMENTS

WHEREAS, Miami-Dade County encompasses more than 2,400 square miles, which makes it larger than the states of Rhode Island and Delaware, and has a total County population of over 2.4 million people, making it the ninth largest county in the U.S. and larger than 16 states; and

WHEREAS, in order to serve this population and land area, the County has made various services available to the public through its internet web portal at www.miamidade.gov, 24 hours per day, seven days per week; and

WHEREAS, residents can also call the County's 3-1-1 answer center, where specialists are available to answer questions in English, Spanish, and Creole; and

WHEREAS, the County has its own access television station known as Miami-Dade TV, which is carried by all cable TV systems in the County; and

WHEREAS, Miami-Dade TV televises County meetings and public information programming on a continuous cycle 24 hours a day, seven days per week; and

WHEREAS, there are County employees who do exceptional work on behalf of the people of Miami-Dade County on a daily basis keeping our community safe, responding to emergencies, providing clean drinking water, providing a safety net for those in need, providing efficient trash pick-up, protecting our environment and keeping buses and trains running; and

WHEREAS, many in the public are not aware of the work done by County employees that touches their lives every day; and

WHEREAS, Miami-Dade TV could serve an important role in making the public aware of the good work of County employees by providing regular broadcasts designed to highlight the achievements of various departments and employees of Miami-Dade County and the work being performed by such departments and employees on a daily basis,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board urges the Mayor or designee to study the feasibility of developing regular Miami-Dade TV programming specifically geared at highlighting the role of various County departments and employees in County government and the work being done by such departments and employees on a daily basis.
