RESOLUTION APPROVING THE WAIVER OF PLAT OF TRUJILLO BROTHERS OF MIAMI-DADE CORP., D-23166, LOCATED IN THE NORTHWEST 1/4 OF SECTION 16, TOWNSHIP 53 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY THE RAILROAD TRACKS SOUTH OF APPROXIMATELY NW 65 STREET, ON THE EAST BY APPROXIMATELY NW 32 COURT, ON THE SOUTH BY NW 62 STREET, AND ON THE WEST BY NW 35 AVENUE)

**WHEREAS**, Trujillo Brothers of Miami-Dade Corp., a Florida corporation, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as all of Block 7 and a portion of Tract "C" of "Dupuis Industrial Center Subdivision", according to the plat thereof, as recorded in Plat Book 57, at Page 56, of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 16, Township 53 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

conforms to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.


