On behalf of the Board of Directors and Executive Director of The Miami Coalition for a Safe and Drug Free Community, it is respectfully recommended that Michele Wyatt-Sweeting be appointed to the Miami-Dade County Addiction Services Board (ASB). Ms. Wyatt-Sweeting has served on the ASB as the representative for the Southern Region of the Florida Department of Children and Families (DCF). She recently resigned from DCF and her role as manager of all Dade and Monroe substance abuse treatment and prevention programs funded by the state, to accept a newly created position of Director of Prevention for the South Florida Behavioral Health Network (SFBHN), Miami and Monroe counties' management entity. In this capacity Ms. Wyatt-Sweeting will manage and oversee all prevention service contracts in the region. She would like to continue to serve on the ASB as a community member. The Miami Coalition Board and staff, who have had years of extensive experience working with Ms. Wyatt-Sweeting, are of the unanimous opinion that she brings a desirable depth of experience and knowledge to assist the ASB in the areas of substance abuse treatment and prevention services.

Ms. Wyatt-Sweeting's experience, insight and contacts will continue to enhance the discussions and information sharing that is a mainstay of the Addiction Services Board's development of goals and achievement of the ASB mission.
