Supplemental County Incentive Grant Resolution Authorizing the Execution of a Program Agreement with the Florida Department of Transportation to Amend the Original Name and Scope For the Northeast Passenger Activity Center to the Northeast Transit Hub Enhancements Project and to Provide Additional State Funding in the

Amount of \$293,485

RECOMMENDATION

It is recommended that the Board of County Commissioners (Board) authorize the execution of a Supplemental County Incentive Grant Program (SCIGP) Agreement in substantially the form attached hereto with the Florida Department of Transportation (FDOT) to amend the original name and scope for the Northeast Passenger Activity Center (NEPAC) to the Northeast Transit Hub Enhancements (NETHE) project and to provide additional funding in the amount of \$293,485.

It is further recommended that the Board authorize the receipt and expenditure of funds as specified in this agreement. Miami-Dade County proposes to provide an equal match of \$293,485 for this SCIGP from Charter County Transportation Surtax (Surtax) Bond proceeds.

While this project is located in County Commission District 4, the impact of this project benefits the riding public, and is therefore, countywide.

FISCAL IMPACT/FUNDING SOURCE

This SCIGP will provide \$293,485 in additional State funding for the NETHE project. Bond proceeds from the Charter County Transportation Surtax (Surtax) will provide the \$293,485 local match for a total agreement amount of \$586,970 (Index code MTPV19NETHE).

The funding for this project is currently programmed in the FDOT Work Program for Fiscal Year (FY) 2010 (\$1,348,442) and FY 2011 (\$293,485) for a total amount of \$1,641,927. The estimated project cost is \$3,283,854. The approximate annual and on-going operation and maintenance for this project is \$8,100.

TRACK RECORD/MONITOR

MDT has entered into numerous funding agreements with FDOT over the course of twenty-five (25) years. The Project Manager for this SCIGP is Carlos de la Torre, Acting Budget Chief, Miami-Dade Transit (MDT) Financial Services.

DELEGATED AUTHORITY

In accordance with Section 2-8.3 of the Miami-Dade County Code related to identifying delegation of Board authority, there are no authorities beyond that specified in the resolution which includes authority for the Mayor, Mayor's designee or the MDT Director to execute the agreement and receive and expend these and any additional funds should they become available.

BACKGROUND

The County Incentive Grant Program was created by Section 339.2817 of the Florida Statutes, as authorized by the 2000 State Legislature. Its purpose is "to provide grants to counties, to improve a transportation facility which is located on the State Highway Systems or which relieves traffic congestion on the State Highway System."

On June 15, 2010, the Board approved the receipt of State funding in the amount of \$1,348,442 for the construction of the Northeast Passenger Activity Center (NEPAC) project (R-687-10). The proposed site for this project was located between NE 164th Street and the Mischon Athletic Field and between NE 15th Avenue and NE 16th Avenue. The plans for the NEPAC project included an enhanced bus hub connecting circulator, and regional and premium bus routes within the NE 163rd Street mall area. The total cost of the NEPAC project at that time was \$6,099,000.

The funding provided through the original CIGP agreement was contingent upon MDT identifying a final site for the NEPAC by January 31, 2011. MDT has worked closely with the City of North Miami Beach on developing the project's preferred site. Assessments were performed by MDT on a number of sites, which included the K-Mart Shopping Mall, NE 163rd Street and Biscayne Boulevard and NE 165th Street between NE 15th Avenue and NE 16th Avenue (the Mishcon site). These locations were evaluated according to specific criteria which included: property's availability, land-use compatibility, transit/pedestrian access, and transit oriented/joint development potential.

The K-Mart site was rejected by the City of North Miami Beach, under City Resolution (R-2004-83). The City, in their resolution, opposed this location based on negative impacts on health, safety, welfare and well-being of the adjacent residential area. Furthermore, citing the location as being too close to the existing I-95/Golden Glades Intermodal Facility and determined it was therefore, not feasible to locate two MDT transit centers within close proximity of the other. In addition, two of MDT's key bus routes (Route 3 and Route H) would not serve this location; thereby, creating an operating gap for passenger connectivity with other MDT routes. Moreover, the North Miami Beach Boulevard serves as a barrier to pedestrian access and raises safety concerns due to existing traffic. In addition, the parking requirements for adjacent retail limits the amount of land available for transit oriented/joint development opportunities.

The NE 163rd Street and Biscayne Boulevard site was also not preferred based upon low compatibility with existing land use, the major landowner being an unwilling seller, and limited transit/pedestrian access coupled with safety concerns by associated traffic from the Biscayne Boulevard/NE 163rd intersection.

The City of North Miami Beach requested that MDT also explore the parking lot behind the Mall at NE 163rd Street and immediately adjacent to the existing bus terminal. However, MDT determined that this location exhibits a low potential for transit oriented/joint development opportunities, if any, due to surrounding land use and limited access. As in the case with K-Mart, the parking requirements for the adjacent retail limited the amount of land available for transit oriented/joint development opportunities.

In accordance with the aforementioned criterion (property availability, land-use compatibility, transit/pedestrian access, and transit oriented/joint development potential) the Mishcon site was considered a preferred location. However, the City of North Miami Beach and MDT were unable to agree on the project scale, scope, and cost for the site. Therefore, it was determined this project was no longer feasible.

Based upon the evaluation of the locations identified as possible sites for the NEPAC project, MDT was unable to identify a site by the State's deadline of January 31, 2011. Therefore, to preserve the funding provided by this agreement, MDT has identified other feasible alternatives. These alternatives include improvements to the existing transit hubs located at the NE163rd Street and Aventura malls. These sites currently have multiple deficiencies (e.g. bus stops, bus shelters, capacity, drainage, pavement, lighting, ADA, signage, access). Both sites provide strategic transit service connectivity as they serve the northeast area and are major destination points with important bus connections. The transit hub locations at the sites include: the NE 167th Street Bus Hub, NE 15th Avenue Bus Hub, NE 163rd Street Bus Stop, Aventura Mall Bus Relief Areas, Aventura Mall Entrance Bus Stop Improvements, and Aventura Mall Publix Shopping Center Stop (NE 29th Place), and will be collectively described as the "Northeast Transit Hub Enhancements" (NETHE). MDT has worked with FDOT and the business owners at these new locations to develop the project scope and obtain their approval.

This is a multi-year agreement, which will provide State funding programmed in FY 2010 (\$1,348,442) and FY 2011 (\$293,485) for a total of \$1,641,927. This funding will be used to correct the aforementioned deficiencies at the existing NE163rd Street and Aventura mall transit hubs. Eligible costs under this SCIGP also include final design, survey, geotech, right-of-way, permitting, construction, CEI and engineering services during construction. The total project cost is \$3,283,854 and is included in the proposed MDT Capital budget for FY 2011-12. Construction is scheduled to commence in January 2013 and be completed by December 2013.

Please note this SCIGP includes a provision for E-Verify. The Board was advised on March 14, 2011 via memorandum that Governor Rick Scott signed Executive Order 11-02 on January 4, 2011, requiring state agencies and their contractors and subcontractors to use this federal web-based system to confirm employment eligibility. As such, this SCIGP includes said provision. The County will utilize the system as required for its own new hires working on contracts paid out of this SCIGP. Furthermore, in the case of contractors and subcontractors, the County will implement the directive of verifying the employment status of same by including provisions in its contracts requiring them to assume the responsibility for performing E-Verification of those individuals who will be used in the work funded by this SCIGP.

EXECUTION OF RESOLUTION **AUTHORIZING** SUPPLEMENTAL COUNTY INCENTIVE GRANT PROGRAM (SCIGP) AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO AMEND THE ORIGINAL NAME AND SCOPE FOR THE NORTHEAST PASSENGER ACTIVITY CENTER TO THE NORTHEAST TRANSIT HUB ENHANCEMENTS PROJECT: TO PROVIDE ADDITIONAL STATE FUNDING IN THE AMOUNT OF \$293,485; AUTHORIZING THE RECEIPT AND EXPENDITURE OF FUNDS AS SPECIFIED IN THE SCIGP; AUTHORIZING RECEIPT AND EXPENDITURE OF ADDITIONAL FUNDS SHOULD THEY BECOME AVAILABLE AS SPECIFIED IN THE SCIGP; AND AUTHORIZING USE OF CHARTER COUNTY TRANSIT SYSTEM SURTAX FUNDS

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, the State of Florida is authorized to enter into agreements to provide State funding for transportation programs and projects,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. That this Board approves the agreement between Miami-Dade County and the Florida Department of Transportation, in substantially the form attached hereto and made a part hereof, in the amount of \$293,485 for final design, survey, geotech, right-of-way, permitting, CEI and engineering services during construction at existing transit hubs located at the NE 163rd Street mall and Aventura mall, collectively known as the Northeast Transit Hub Enhancements (NETHE) project.

Section 2. That this Board further authorizes the Mayor, Mayor's designee, or Miami-Dade Transit Director, to execute such contracts and agreements as are approved by the County Attorney's Office; to receive and expend funds in accordance with such aforementioned

contracts and agreements; to receive and expend any additional funds should they become available; and to file and execute any additional agreements, revisions, or amendments as required to carry out the projects for and on behalf of Miami-Dade County, Florida.




