Application for Funds, 2011 Response to Gun Fire Grant

Recommendation

It is recommended that the Board approve the attached resolution retroactively authorizing the County Mayor and/or County Mayor's designee's action to apply for, receive, and expend federal funds in the amount of \$350,000 from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, to support the Miami-Dade Police Department (MDPD). The grant period will be effective October 1, 2011 through September 30, 2014 and does not require any matching local or in-kind funds.

Scope

This grant will provide countywide services.

Fiscal Impact/Funding Source

This grant will provide \$350,000 in federal funds to implement the proposed project. The grant does not require any matching local or in-kind funds. The funding source is the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance.

Track Record/Monitor

The grant will be monitored by the Chief Financial Officer of the Miami-Dade Police Department (MDPD).

Background

Ratification of this application is necessary because the proposal did not allow time to submit the resolution to the Board prior to submitting the application. The **Response to Gun Fire** program is a training program developed by the MDPD. It is an innovative program which incorporates sound tactical principles and other components that will result in improved officer mindset, confidence, and response to be on alert when an officer suspects or is confronted with gun fire. Deliverables include a toolkit of the training curriculum, a sustainability plan to institutionalize the program, and a Train-the-Trainer component for other law enforcement agencies training students as instructors to implement this program at their agencies. Funding will also support the training of MDPD sworn personnel.
