RESOLUTION APPROVING THE CITY OF HIALEAH
CODESIGNATION OF WEST 23 STREET FROM WEST 6
COURT TO WEST 7 COURT AS "MARSHALL WAY"

WHEREAS, on April 12, 2011, the Hialeah City Council adopted Resolution No. 11-28, which designated West 23 Street from West 6 Court to West 7 Court as "Marshall Way," in recognition of Steve Marshall's contributions to the City of Hialeah, a copy of which is attached and incorporated by reference; and

WHEREAS, Steve Marshall was born on August 23, 1925 to Ben Marshall and Rebecca William-Marshall, the first African-American family to settle and work in the Hialeah community of Seminola; and

WHEREAS, Steve Marshall worked for the Hialeah Racetrack, the Hialeah Police Department and as a private security guard and tirelessly worked for the betterment of his community; and

WHEREAS, Steve Marshall is one of seven chartered committee members of the Historical Development Committee of Seminola, founded in 2007; and

WHEREAS, West 23 Street from West 6 Court to West 7 Court is a city street located in the City of Hialeah; and

WHEREAS, the City of Hialeah wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, this codesignation is located in County Commission District 13,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Hialeah codesignation of West 23 Street from West 6 Court to West 7 Court as “Marshall Way.”

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Miami-Dade County Public Works Department, the Land Development Division of the Public Works Department, the Hialeah Police Department and the Hialeah Fire Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE CODESIGNATION OF A PORTION OF WEST 23 STREET, BETWEEN WEST 6 COURT AND WEST 7 COURT, HIALEAH, FLORIDA, AS "MARSHALL WAY", IN HONOR AND RECOGNITION OF THE OUTSTANDING SERVICE AND DEDICATION OF STEVE MARSHALL, SR. TO THE CITY OF HIALEAH AND ITS RESIDENTS, WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY.

WHEREAS, the codesignation of that portion of West 23 Street, between West 6 Court and West 7 Court, as "MARSHALL WAY", presently unnamed, is in honor and memory of the outstanding contributions of Steve Marshall, Sr. ("Steve Marshall"); and

WHEREAS, a street sign designating "MARSHALL WAY" previously erected by the City of Hialeah was subsequently torn down, and the street was never formally dedicated by the Hialeah City Council; and

WHEREAS, Steve Marshall was a proud resident of the Hialeah community of Seminola for over 60 years, and is loved by Hialeah residents for his invaluable service and dedication to his community; and

WHEREAS, Steve Marshall was born on August 3, 1925, to Ben Marshall and Rebecca William-Marshall, the first black family recruited to work and settle in Seminola in 1909; and

WHEREAS, like his father before him, he was a proud employee of the Hialeah Racetrack; and

WHEREAS, he also worked for the City of Hialeah Police Department, and as a private security guard; and

WHEREAS, Steve Marshall is one of seven chartered committee members of the Historical Development Committee of Seminola, founded in 2007; and

WHEREAS, Steve Marshall's tireless dedication to the betterment of his community is worthy of recognition; and



Section 1: The portion of West 23 Street, between West 6 Court and West 7 Court, Hialeah, Florida, presently unnamed, is hereby co-designated as "MARSHALL WAY", and shall be known as such from this day forward, with the costs of signage to be paid by the City.


