

RESOLUTION APPROVING THE CITY OF HIALEAH  
CODESIGNATION OF WEST 27 STREET FROM WEST 8  
AVENUE TO WEST 9 AVENUE AS "SERVELIO DEL VALLE  
WAY"

**WHEREAS**, on April 12, 2011, the Hialeah City Council adopted Resolution No. 11-29, which designated West 27 Street from West 8 Avenue to West 9 Avenue as "Servelio Del Valle Way," in recognition of Servelio Del Valle's contributions to the City of Hialeah and to the community, a copy of which is attached and incorporated by reference; and

**WHEREAS**, Servelio Del Valle was born in Cuba, where his love for sports flourished into what later became a successful career in radio broadcasting in the U.S.; and

**WHEREAS**, during his career, Del Valle broadcast games for the University of Miami Hurricanes and the Miami Heat; and

**WHEREAS**, in 1990, Del Valle was named the most popular radio sports personality in Miami; and

**WHEREAS**, Del Valle played an important role in local baseball leagues, where he was loved and respected throughout City of Hialeah parks; and

**WHEREAS**, on May 28, 2009 Servelio Del Valle passed away; and

**WHEREAS**, West 27 Street from West 8 Avenue to West 9 Avenue is a city street located in the City of Hialeah; and

**WHEREAS**, the City of Hialeah wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

**WHEREAS**, this codesignation is located in County Commission District 13,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

Section 1. Approves the City of Hialeah codesignation of West 27 Street from West 8 Avenue to West 9 Avenue as “Servalio Del Valle Way.”

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Miami-Dade County Public Works Department, the Land Development Division of the Public Works Department, the Hialeah Police Department and the Hialeah Fire Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner \_\_\_\_\_, who moved its adoption. The motion was seconded by Commissioner \_\_\_\_\_ and upon being put to a vote, the vote was as follows:

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE CO-DESIGNATION OF A PORTION OF WEST 27 STREET, BETWEEN WEST 8 AVENUE AND WEST 9 AVENUE, HIALEAH, FLORIDA, AS "SERVELIO DEL VALLE WAY", IN HONOR AND MEMORY OF THE OUTSTANDING SERVICE OF SERVELIO DEL VALLE TO THE CITY OF HIALEAH AND ITS RESIDENTS, WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY.

WHEREAS, the co-designation of that portion of West 27 Street, between West 8 Avenue and West 9 Avenue, as "SERVELIO DEL VALLE WAY", presently unnamed, is in honor and memory of the outstanding service of Servelio Del Valle to the City of Hialeah and its residents; and

WHEREAS, Servelio Del Valle was a resident of the City of Hialeah from 1971 until his death in 2009; and

WHEREAS, Servelio Del Valle served his community as an outstanding citizen, father, husband, and grandfather; and

WHEREAS, Servelio Del Valle was born in the small town of Fomento, in Las Villas, Cuba, where his love for sports flourished into what later became a distinguished career in sports radio in his new homeland; and

WHEREAS, despite his success in the United States, he never forgot his roots as a small-town Cuban boy playing in the fields; and

WHEREAS, Servelio Del Valle's love of sports was evident in his sports program broadcasts on Radio Mambi, La Grande, a station heard throughout South Florida; and

WHEREAS, in 1990, he was named the most popular radio sports personality in the City of Miami, and retained this honor throughout his career; and

WHEREAS, Servelio Del Valle broadcasted games for the University of Miami Hurricanes and the Miami Heat; and

WHEREAS, during the course of his illustrious career, he interviewed many sports legends, including Joe DiMaggio, Tany Perez, Orestes "Minnie" Miñoso, and Pele; and

WHEREAS, Servelio Del Valle was instrumental in the local baseball league, where he was loved and respected throughout the City of Hialeah parks; and

WHEREAS, the Historic Preservation Board recommended approval of this resolution on March 23, 2011.

THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:




