

RESOLUTION DIRECTING THE COUNTY MAYOR OR THE COUNTY MAYOR'S DESIGNEE TO REPORT, WITHIN 60 DAYS, TO THE BOARD REGARDING THE BEST METHODOLOGY AND IMPLEMENTATION SCHEDULE TO PROCURE A GUNSHOT DETECTION SYSTEM FOR THE MIAMI-DADE POLICE DEPARTMENT

WHEREAS, a gunshot detection system is a system that detects and conveys the location of gunfire or other weapon fire using acoustic, optical, potentially other types of sensors, as well as a combination of such sensors; and

WHEREAS, law enforcement, homeland security, and private security parties use these systems to identify the source and, in some cases, the direction of gunfire and/or the type of weapon fired; and

WHEREAS, gunfire detection systems have been successfully deployed in other jurisdictions and have resulted in more effective crime detection and prevention; and

WHEREAS, the Board of County Commissioners wishes to purchase and deploy a gunfire detections system in Miami-Dade County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor or County Mayor's designee to prepare a report regarding the best methodology and implementation schedule to procure a gunshot detection system in Miami-Dade County. Such system shall be used by the Miami-Dade Police Department to identify whether gunshots have been fired; the location of the shooter firing the gunshots; the sequence of gunshots fired; and whether the shooter was moving or stationary when the gunshots were fired. Such system

shall also provide investigators from the Miami-Dade Police Department with data that can be processed and utilized in the investigation of gunshot incidents. Such report shall be presented to the Board of County Commissioners for further action within sixty (60) days of the effective date of this resolution.

The Prime Sponsor of the foregoing resolution is Chairman Joe A. Martinez and the Co-Sponsor is Commissioner Jose "Pepe" Diaz. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
