

A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$790.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 1 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, Mt Zion A.M.E. Church , Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the May 7, 2011 "Operation Savior" in an amount not to exceed \$790.00 (see attached Fee Waiver/In-kind Service Application); and





Subject: District Specific In-Kind Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Mt Zion A.M.E. Church, Inc. for their "Operation Savior" event held on May 7, 2011.

In-kind services have been requested in an amount not to exceed \$790 from the Miami-Dade Park and Recreation Department for the use of a stage. This event will be funded from the unspent balance of the District 1 FY 2008-09 in-kind reserve fund.

In FY 2010-11, Mt Zion A.M.E. Church, Inc., received \$2,000 from District 1 discretionary fund.
