**This item has been amended to reflect the change made at the October 26, 2011 Economic Development and Social Services Committee meeting. Specifically, the item is amended to reflect on handwritten page 8 Madeline D'Arce as the District 11 representative.**

## **Recommendation**

It is recommended that the Board of County Commissioners (BCC) select and appoint nine (9) of the eleven (11) nominees being submitted by the Community Action Agency (CAA) Community Representatives Nominating Committee (Nominating Committee), for appointment to the Community Action Agency Board (CAA Board) for the 2011-2013 term. At the time of advertisement, nine (9) vacancies existed on the CAA Board. It is anticipated that all members appointed through this process will begin their two year term in November 2011.

## **Scope**

The CAA Board serves the interests of low-income individuals, families and communities countywide.

## **Fiscal Impact/Funding Source**

There is no fiscal impact to the County for this action. CAA Board members are stewards of the community who serve voluntarily without compensation. Members are entitled to reimbursement for expenses incurred for out of town travel on behalf of the department in accordance with Florida Statute 112.061. These expenses are funded through the respective grants associated with the travel.

## **Track Record/Monitor**

The CAA Executive Director is responsible for the oversight and reporting of the CAA Board.

## **Background**

The Miami-Dade Community Action Agency Board was formally established by the BCC through Ordinance 09-31. The CAA Board is a tri-partite board consisting of one third of its members being elected officials or their designees, one third comprised of citizen representatives from low-income communities in accordance with the Community Services Block Grant funding, and one third comprised of representatives from community interests groups or organizations. Members representing community interests or organizations are appointed to the CAA Board by the BCC for a term of two years.

The Nominating Committee convened by the County Mayor pursuant to Ordinance 09-31, consisted of CAA Board member Irene Taylor-Wooten, designee for CAA Board Chair, Dr. William Zubkoff, Sonia Grice, designee of Mayor Carlos Gimenez, and Ivonne Perez-Suarez, designee of Commissioner Rebeca Sosa, Chair of the Economic Development and Social Services Committee, the Committee of Jurisdiction for the CAA Board.

The Nominating Committee received a total of twenty-four (24) applications, including nine (9) from incumbent members. Of the twenty-four applications, twenty-one (21) were received by

the published deadline. As such, only twenty-one applicants were scheduled for interviews with the Nominating Committee. In addition to face-to-face interviews, the Nominating Committee agreed to allow telephone interviews for those candidates who requested such consideration due to special circumstances. Of those scheduled for interviews, one person declined and another could not be contacted following numerous attempts on the day of the interviews. It was agreed that all applicants, including the incumbents, would be rated with the same instrument. In addition to the questions posed to all applicants, the incumbents had the opportunity to share their experience of being on the CAA Board over the past two years in addition to addressing their attendance. A copy of the attendance record is included as Attachment 1. Eleven (11) of the nominees, nine (9) of which are incumbents, are being forwarded to the BCC for consideration as required by the Ordinance.

Following the interviews and Committee's deliberations, the recommended slate of candidates were reviewed and discussed with Dr. Zubkoff who endorsed the recommended slate of candidates to fill vacant positions that represent the Community Interest and Organizations sector of the tri-partite CAA Board. In accordance with the Ordinance, the BCC shall make the appointments to the CAA Board from the candidates recommended by the Nominating Committee or request a new list of candidates for any of the vacant positions.

Additionally, in accordance with the procedures of the Nominating Committee, advertisement for the Community Representative Board members were placed in The Miami Herald, The Miami Times, Diario Las Americas, and Haiti en Marche. The advertisement was also posted on Miami-Dade County's web portal from June 21, 2011 through July 8, 2011. Additionally, the request for nominees was also discussed at several CAA Board meetings and all Citizen Participation members on the CAA Board were requested to advise their respective Community Advisory Committee (CAC) members of the vacancies. Submission of applications for the Community Representative Board member positions were due to the Clerk of the Board of County Commissioners on or before July 8, 2011. Twenty-one applications were received by the due date and time, and three were received subsequently, and thus considered late. A copy of all applications are included as Attachment 2.

During the August 8, 2011, Nominating Committee meeting, the Committee voted to recommend the persons listed below for appointment to the CAA Board for a period of two years each. The 2011-2013 appointees will begin their two year term in November 2011. In accordance with the Ordinance, two additional names must be included with the list forwarded for consideration.
