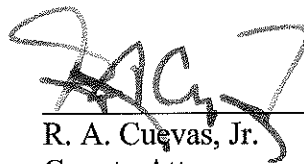

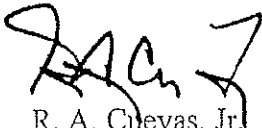

RESOLUTION APPROVING THE CITY OF NORTH MIAMI
CODESIGNATION OF NW 127TH STREET FROM NW 7TH
AVENUE TO NW 17TH AVENUE AS "MASTER RUBINOFF
D. ROBINSON, SR. STREET"

WHEREAS, on November 8, 2011 the City of North Miami Commission adopted Resolution No. R-2011-145 which designated NW 127th Street from NW 7th Avenue to NW 17th Avenue as "Master Rubinoff D. Robinson, Sr. Street," in recognition of his contributions to the City of North Miami, a copy of which is attached and incorporated herein; and

WHEREAS, Master Robinson served the Miami-Dade Public School system for thirty two years; and

WHEREAS, Master Robinson founded and led Quality United Education, Inc., a not-for-profit organization dedicated to the betterment of the youth of Miami-Dade County; and

WHEREAS, Master Robinson worked closely with the North Miami Police Department on several projects geared toward fighting crime in the community; and

WHEREAS, Master Robinson passed away on February 28, 2011; and

WHEREAS, NW 127th Street from NW 7th Avenue to NW 17th Avenue is a city street located in the City of North Miami; and

WHEREAS, the City of North Miami wants the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this codesignation is located in County Commission District 2,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of North Miami codesignation of NW 127th Street from NW 7th Avenue to NW 17th Avenue as “Master Rubino D. Robinson, Sr., Street.”

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of North Miami, the Clerk of the City of North Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department and Land Development/Right-of-Way Division of the Public Works and Waste Management Department, the North Miami Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Jean Monestime. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:

RESOLUTION NO. R-2011-145

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, DESIGNATING N.W. 127TH STREET FROM N.W. 7TH AVENUE WEST TO N.W. 17TH AVENUE TO BE KNOWN AS "MASTER RUBINOFF D. ROBINSON, SR. STREET"; AUTHORIZING THE CITY MANAGER TO ALLOCATE AND EXPEND THE NECESSARY FUNDS TO COVER THE COSTS FOR SIGNAGE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, Master Rubinoff D. Robinson, Sr. ("Master Robinson") resided in Miami-Dade County for over fifty (50) years; and

WHEREAS, Master Robinson served the Miami-Dade Public School System for thirty-two (32) years; and

WHEREAS, Master Robinson founded and led Quality United Education, Inc., a not-for profit organization dedicated to betterment of the youth of Miami-Dade County; and

WHEREAS, Master Robinson utilized martial arts to inspire North Miami residents at Linda Lentin K-8 Education Center; and

WHEREAS, Master Robinson partnered with the North Miami Police Department on National Night Out Against Crime and PAL's F.A.C.T. Festival (Families Against Crime Together); and

WHEREAS, Master Robinson's service on earth ended with his death on February 28, 2011; however, his legacy will continue forever; and

WHEREAS, in recognition of his continuing dedication and commitment to the City of North Miami and its youth, the Mayor and City Council wish to designate N.W. 127th Street from N.W. 7th Avenue west to N.W. 17th Avenue to be known as "Master Rubinoff D. Robinson, Sr. Street"; and

WHEREAS, the Mayor and City Council desire to authorize the City Manager to allocate and expend the necessary funds to cover the costs of any and all signs to indicate the designation of said street as "Master Rubinoff D. Robinson, Sr. Street."

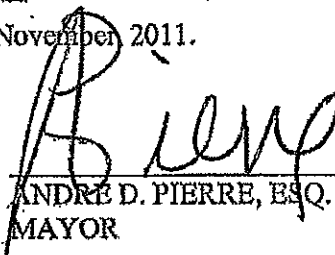
NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Approval of Street Designation. The Mayor and City Council of the City of North Miami, Florida, hereby designate N.W. 127th Street from N.W. 7th Avenue west to N.W. 17th Avenue to be known as "Master Rubinoff D. Robinson, Sr. Street."

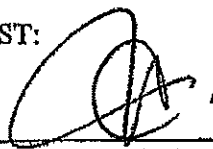

Section 4. Effective Date. This Resolution shall become effective immediately upon adoption.

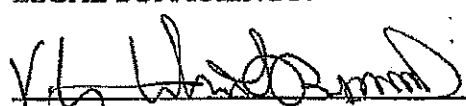
