RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE POLICE DEPARTMENT AND THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE OCTOBER 28, 2012 "DIA NACIONAL DEL EMIGRANTE, EL EXILIADO Y EL DESTERRADO" EVENT SPONSORED BY FUNDACION PATRICIA DE AYUDA SOCIAL, HUMANITARIA Y RELIGIOSA, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,000 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 11 FY 2008-09 IN-KIND RESERVE FUND




