RESOLUTION WAIVING TERM LIMITS FOR REAPPOINTMENT OF VT WILLIAMS TO THE HOUSING FINANCE AUTHORITY OF MIAMI-DADE COUNTY; AND REQUIRING TWO-THIRDS VOTE OF THE BOARD FOR APPROVAL

WHEREAS, on January 21, 2010, the Board of County Commissioners (the "Board") enacted Ordinance No. 10-06, amending Chapter 2, Section 2-11.38.2 of the Code of Miami-Dade County, to permit the waiver of term limits for county board members; and

WHEREAS, pursuant to Section 2-11.38.2 of the Code of Miami-Dade County, no board member shall serve for more than eight (8) consecutive years on a board, unless waived by a two-thirds (3/3) vote of the members present of the Board; and

WHEREAS, pursuant to Section 2-191.5 of the Code of Miami-Dade County, members of the Housing Finance Authority have terms of four (4) years; and

WHEREAS, this Board wishes to waive the applicable term limits and reappoint VT Williams to the Housing Finance Authority for another four (4) year term,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the Board authorizes and approves, by two-thirds (%) vote, the reappointment of VT Williams to an additional four (4) year term on the Housing Finance Authority.
