Subject: Resolution approving the Waiver of Plat for the ESTATE OF JOSEPH A. GUGGINO

Recommendation

The following waiver of plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north by SW 216 Street, on the east approximately 300 feet west of SW 179 Avenue, on the south approximately 320 feet north of SW 218 Street, and on the west by SW 180 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources, Public Works and Waste Management, and Water and Sewer, recommends approval of this waiver of plat.

Scope

This waiver of plat is located within Commission District 8 (Commissioner Bell).

Fiscal Impact/Funding Source

There is no associated fiscal impact to Miami-Dade County with the approval of this waiver of plat; all improvements are in place.



RESOLUTION APPROVING THE WAIVER OF PLAT OF THE ESTATE OF JOSEPH A. GUGGINO, D-23354, LOCATED IN THE NORTHEAST 1/4 OF SECTION 13, TOWNSHIP 56 SOUTH, RANGE 38 EAST (BOUNDED ON THE NORTH BY SW 216 STREET, ON THE EAST APPROXIMATELY 300 FEET WEST OF SW 179 AVENUE, ON THE SOUTH APPROXIMATELY 320 FEET NORTH OF SW 218 STREET, AND ON THE WEST BY SW 180 AVENUE)

WHEREAS, the Estate of Joseph A. Guggino, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Northeast 1/4 of Section 13, Township 56 South, Range 38 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,
