



ORDINANCE NO. _____

ORDINANCE AMENDING SECTION 2-1311 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA, TO ADD A SUNSET PROVISION; PROVIDING SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE

WHEREAS, Miami-Dade County created the Dial-A-Life program in 2001 to provide free cell phones to the disadvantaged for emergency use only; and

WHEREAS, services such as Safelink or Assurance Wireless already provide free cell phones for emergency use only to individuals who are low income, disabled, parent of a disabled child, elderly, or a victim of domestic abuse; and

WHEREAS, the services provided by the Miami-Dade County's Dial-A-Life program are no longer necessary,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA:

Section 1. Section 2-1311 of the Code of Miami-Dade County, Florida, is hereby amended to read as follows:¹

ARTICLE LXXXIX. DIAL-A-LIFE PROGRAM

Sec. 2-1311. Creation; operations.

* * *

¹ Words stricken through and/or [[double bracketed]] shall be deleted. Words underscored and/or >>double arrowed<< constitute the amendment proposed. Remaining provisions are now in effect and remain unchanged.

>>C. Sunset. The provisions of this ordinance shall sunset on June 15, 2013, unless otherwise reenacted by the Board of County Commissioners.<<

Section 2. If any section, subsection, sentence, clause or provision of this ordinance is held invalid, the remainder of this ordinance shall not be affected by such invalidity.

Section 3. It is the intention of the Board of County Commissioners, and it is hereby ordained that the provisions of this ordinance, including any sunset provision, shall become and be made a part of the Code of Miami-Dade County, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section," "article," or other appropriate word.

Section 4. This ordinance shall become effective ten (10) days after the date of enactment unless vetoed by the Mayor, and if vetoed, shall become effective only upon an override by this Board.
