Dear Honorable Chairwoman Sosa:

Pursuant to Section 2-1076 of the Code of Miami-Dade County, the Ad Hoc Inspector General Selection Committee (the Committee) was convened to select and recommend to the Board of County Commissioners the appointment of the next Miami-Dade County Inspector General. Through the efforts of the Human Resources Department, a national recruitment was conducted that generated a wealth of highly qualified applicants for consideration. From the group of qualified applicants, the Committee selected a total of 15 candidates (two of whom withdrew their names) and interviewed a total of thirteen highly qualified individuals.

After serious consideration, the Committee recommends the appointment of Ms. Mary Cagle as the next Inspector General of Miami-Dade County.
