

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE OCTOBER 20, 2013 "BOW-WOW BONANZA" EVENT SPONSORED BY BAUSER'S PET TRAINING, LLC. IN AN AMOUNT NOT TO EXCEED \$650.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 4 FY 2013-14 IN-KIND RESERVE FUND

WHEREAS, Bauser's Pet Training, LLC. has requested in-kind services from the Parks, Recreation and Open Spaces Department for the October 20, 2013 "Bow-Wow Bonanza" event in an amount not to exceed \$650.00 (see attached Fee Waiver/In-kind Service Application); and






