Julio Magrisso, Assistant Director of the City of Miami Beach Parks and Recreation Department, is dedicated to community service. The health and wellness of families and children have been his particular focus for over 20 years.

His involvement began as a mentor and coach to neighborhood children. While simultaneously nurturing his successful career in finance and management, he coached hundreds of children in Little League baseball. In time, his family's blue Chevy Conversion Van transported entire baseball teams to practice and games. Later on, Julio became an Assistant Coach for the Miami Beach High School baseball team.

Many years on City of Miami Beach Boards led to more advocacy. He has served as Vice Chair of the Manager's Blue Ribbon Committee on Recreation, Co-Chairman of the Youth Center Advisory Board and Vice Chair of the Parks & Recreation Facilities Advisory Board. In the late 1990's, Julio joined the Board of Directors of the South Florida After-School All-Stars (formerly the South Florida Inner City Games). Founded by former Gov. Arnold Schwarzenegger, the organization is a national model for after school care. Locally, it serves over 2,500 children in 26 middle schools in Miami Dade County. Fourteen years later, Julio continues to serve on its Board as Treasurer and Chairman of the Finance Committee.

In December of 2002, the City of Miami Beach began to compensate Julio for his extensive efforts. In his capacity as Assistant Director of the Parks and Recreation Department, a television documentary in early 2008 inspired him to create a Surf Camp for children with Autism in collaboration with Dr. Michael Alessandri at the University of Miami-Nova Southeastern University Center for Autism and Related Disabilities (UM-NSU CARD). The partnership between the two organizations has provided a therapeutic surfing experience for campers ages 8 to 12 with high-functioning Autism, Pervasive Developmental Disorder, or Asperger's Syndrome.

During Surf Camp, participants learn to ride surfboards, build sand castles, socialize and enjoy the ocean. The curriculum enhances each child's individual abilities in swimming, basic oceanography, meteorology and open-water surfing. The camp, now entering its sixth year, has proven popular with the kids and the parents, who often cry upon witnessing their children ride a wave. Social goals are also addressed, and many surfers achieve broader independence. As the first program of its kind on the east coast of the United States, the camp gets national and local media coverage and is considered a model for other inclusive experiences.

During Julio's tenure at the City of Miami Beach, the number of children with disabilities participating in the City's recreational programs has grown significantly. Today, children with disabilities enjoy the type of childhood activities that neuro-typical youth – and their parents – often take for granted. For improving the lives of these families, the Community Committee for Developmental Handicaps (CCDH) and its All Children Together Program ACT recognized the City of Miami Beach Parks and Recreation Department with the **Inclusion in ACTION Award** in 2012. In April 2012, UM-NSU CARD recognized Julio and his team with the **Outstanding Community Service Award**.

Mr. Magrisso has been married to Edmee for 29 years and is the father of two children, Jason 26 and Kelsey 22. He graduated with a Bachelor of Science Degree in Accounting from the University of Florida in June, 1982.







Kindly accept my application to serve as a member of the Board of Directors of The Children's Trust. I believe that I am well suited to serve in this capacity, given my education, expertise, and strong record of service to children and families in our community since moving to Miami in 1981.

Before coming to Miami, I worked in the Department of Pediatrics at the University of Kentucky, where I served as administrative coordinator in a multidisciplinary program for children with profound disabilities and their families. After arriving in Miami I completed training for the Guardian ad Litem program and served briefly while I attended school full time. This experience served as an introduction to some of the needs of children and families in our community.

When I served as Coordinator in the Family English Literacy Program at FIU, I coordinated programs for Spanish speakers in several schools in Dade and Broward Counties. This assignment included development of curriculum and lesson plans for use in a school-based literacy program, working with school administrators and parents, and providing instruction. Frequently, parents and family members coming to these English literacy programs were illiterate in Spanish as well.

My experience working with immigrant children, youth, and families is extensive. I was part of the team that worked on a study of immigration in South Florida that resulted in the 1991 State of Florida report "Forecasting the Impact of Immigration on the Provision of Municipal Services in Dade County." I was responsible for the field survey component, training Spanish and Haitian-Creole speakers as interviewers, supervising their work in the community, including interviewing the large influx of Central American refugees that were housed at the Bobby Maduro Stadium and immigrants detained at the Krome Detention Center.

In my 30 years at Florida International University, my work, research, and service focused on the education continuum, culminating in research and advocacy to strengthen preparation for, access to, and success in college leading to graduation.


This commitment to students and families led to my being appointed the FIU lead in ENLACE (Engaging Latino Communities in Education), a project initially funded by the W.K. Kellogg Foundation, later expanded to the state-wide network ENLACE Florida, with support from the SUS Board of Governors and Florida Legislature, and now known as the Florida College Access Network (FCAN). As the South Florida lead, I worked with representatives from the Miami-Dade School System, Aspira Florida, enFamilia, and other community organizations.

After retiring from FIU in 2012, I worked for five months as a consultant with a start-up college, and I continue to develop consulting opportunities in areas related to my education and experience. 


