

RESOLUTION DIRECTING THE MAYOR OR MAYOR'S
DESIGNEE TO ESTABLISH AN ADVERTISEMENT
CAMPAIGN UTILIZING EXISTING COUNTY CONTRACTS
TO INFORM ELIGIBLE SMALL BUSINESSES AND
ENCOURAGE THEM TO BECOME CERTIFIED FOR
VARIOUS SMALL BUSINESS DEVELOPMENT PROGRAMS

WHEREAS, Miami-Dade County and this Board values the vital role of small businesses in our community; and

WHEREAS, all eligible contracts are subject to the inclusion of workforce goals and small business goals through various programs such as the Community Business Enterprise, Community Small Business Enterprise, and the Small Business Enterprise; and

WHEREAS, in addition to the resources available on Miami-Dade County's Internal Services Department Small Business Development (SBD) website, the County should reach out and inform the public at large and eligible small businesses in particular of the programs and resources available for small businesses; and

WHEREAS, SBD currently seeks to increase small business participation through targeted, active recruiting of firms in areas where there is little or no availability for certain commodities which the County procures; and

WHEREAS, this targeted recruitment is valuable and an efficient use of resources currently available, a broader active approach to soliciting small business participation through resources available at no cost and on a more countywide basis would enhance SBD's mission and benefit the community; and

WHEREAS, the Mayor or Mayor's designee should establish an advertising campaign to publicize these small businesses resources and encourage firms to seek more information and become certified where eligible; and

WHEREAS, this advertising campaign can and should utilize existing county contracts to reach the target audience at little or no cost to the County, including Miami-Dade TV, county mailers, circulators and eligible transit advertising (Metro Rail/Metro Mover/ Metro Bus as well as benches, facilities and shelters),

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the Mayor or Mayor's designee is directed to establish an advertisement campaign utilizing existing county contracts to inform eligible small businesses and encourage them to become certified for various small business development programs.
