Subject: Contract Award Recommendation in the Amount of \$203,898.07 to Leyram Construction, Inc. for the People's Transportation Plan Project Entitled Sidewalk Improvements; and Authorizing the Use of Charter County Transportation Surtax Funds

Recommendation

The attached Contract Award Recommendation for the People's Transportation Plan (PTP) project entitled *Sidewalk Improvements* (Project MCC 7040 Plan - CICC 7040-0/07 Request for Price Quotation No. 20130205) in the amount of \$203,898.07 to Leyram Construction, Inc., was prepared by the Public Works and Waste Management Department (PWWM) and is recommended for approval by the Board of County Commissioners (BCC).

This Contract Award Recommendation is placed for Committee review pursuant to Miami-Dade County Code Section 29-124(f). This Contract Award Recommendation may only be considered by the BCC if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the BCC prior to the date scheduled for BCC consideration or forty-five (45) days have elapsed since the filing with the Clerk of the Board of this contract award recommendation. If the CITT has not forwarded a recommendation and forty-five (45) days have not elapsed since the filing of this award recommendation, I will request a withdrawal of this item.

Scope

The work to be performed under this Contract includes sidewalk improvements along:

1. SW 72 Court and SW 13 Street, Commissioner Rebeca Sosa's District 6;
2. SW 4 Street, from SW 89 Court to SW 87 Avenue, Commissioner Rebeca Sosa's District 6;
3. NW 37 Avenue and NW 7 Street, Commissioners Bruno A. Barreiro's District 5 and Rebeca Sosa's District 6;
4. 4611 SW 127 Court, Commissioner Javier D. Souto's District 10;
5. 9460 Palmetto Club Lanes East, Commissioners Lynda Bell's District 8 and Dennis C. Moss's District 9;
6. 5700 SW 35 Street, Commissioner Rebeca Sosa's District 6;
7. 7891 SW 14 Terrace, Commissioner Javier D. Souto's District 10;
8. 9131 SW 19 Street, Commissioner Javier D. Souto's District 10;
9. 8001 SW 94 Court, Commissioner Javier D. Souto's District 10;
10. NE 215 Street and NE 10 Avenue, Commissioner Barbara J. Jordan's District 1
11. 2181 SW 80 Street, Commissioner Javier D. Souto's District 10;
12. NW 131 Street, from NW 17 Avenue to NW 22 Avenue, Commissioner Jean Monestime's District 2.

Fiscal Impact/Funding Source

The fiscal impact will be approximately \$203,898.07 and will be funded from Charter County Transportation Surtax Bond Sale Proceeds, and Secondary Gas Tax.

The base contract amount is \$175,090.06, with the total amount being inclusive of contingency and dedicated allowance amounts. There is no fiscal impact to operations or maintenance.

The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. The funding index codes for this Project are, CPEPTP702RWN, CPEPTP706SDW, CPE10SEC, CPE08SEC, CPE06SEC and CPE01SEC (FY 2013-14 Adopted Capital Projects 609610, 606790 and 6037700).

Delegation of Authority

No additional authority is being requested within the body of this Contract.

Track Record/Monitor

Leyram Construction, Inc. is performing work for PWWM at a satisfactory level. The Capital Improvements Information System (CIIS) database lists 17 awarded construction contracts all from PWWM. The referenced database also lists a total of 31 contractor performance evaluations (several contracts having two evaluations on file, an interim and project closeout) with an overall performance rating of 3.5 (satisfactory performance), out of a possible 4.0 (superior performance) rating. The Regulatory and Economic Resources Department, Small Business Development Division (SBD) History of Violation's report lists no violations for this contractor.

According to the Florida Department of State, Division of Corporations, Leyram Construction, Inc., Company Principal is Ariel R. Portilla and the Company's address is listed as 11612 NW 57 Avenue, Hialeah, Florida 33012.

Following PWWM's standard operating procedures, after award of this Contract a pre-construction meeting will be scheduled. The person responsible for all PTP projects in PWWM is PTP Coordinator, Mr. Alejandro Martinez-Esteve, RA, LEED AP. Following completion of the award process, the project will be assigned to Mr. Rene Idarraga, Project Coordinator, for day-to-day responsibilities.

Background

As part of the PTP Neighborhood Improvements initiative, PWWM continues to take advantage of various contracting mechanisms such as the Miscellaneous Construction Contracting process available under the MCC 7040 Program. Through this process, PWWM forwards a Request for Price Quotation (RPQ), by way of facsimile transmission, to a pool of pre-qualified Community Small Business Enterprise (CSBE) contractors for the respective trade. Additionally, all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" link. The project's award evaluation is based upon the bid submitted by the lowest responsive, responsible bidder for the project.

PWWM staff determined that the scope of work for this project qualified for a CSBE set-aside. A Community Workforce Program Goal was deemed not applicable to this RPQ. On August 15, 2013, PWWM forwarded an RPQ for the Sidewalk Improvements, utilizing the

MCC 7040 Plan - CICC 7040-0/07 Contract, to a list of 45 pre-qualified firms. A total of four (4) firms purchased contract documents and three (3) firms proffered a bid.

On September 18, 2013, Leyram Construction, Inc. proffered the lowest responsive and responsible base bid of \$175,090.06, 15 percent below the County's cost estimate. The second lowest bidder, Quality Paving Corp. proffered a base bid of \$224,218.50, eight (8) percent above the County's cost estimate.

The third lowest bidder, JVA Engineering Contractors, Inc. proffered a base bid of \$280,736.50, 36 percent above the County's cost estimate. Based on the results of the solicitation, PWWM issued a recommendation for award on October 1, 2013 for RPQ No. 20130205 to Leyram Construction, Inc., with the stipulation that approval for this project must be obtained from the CITT and the BCC.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, equipment, and tools to perform all operations necessary for sidewalk improvements. The work includes construction of new curb ramps and gutters, sidewalks, driveway approaches, the removal and disposal of various existing pavements, the grading and preparation of subgrade, the removal and disposal of existing trees, tree roots, and debris, clearing and grubbing, adjustment of existing utility valve covers to new finished grade and sodding. PWWM works with Commission District offices to identify needed sidewalk improvements, and to obtain the approval of the use of each office's Neighborhood Improvement PTP allocation. Additionally, this contract will be utilized to address sidewalk accessibility issues identified and funded through the County's ADA Hotline Program.

This letter will serve as your notification that you have been recommended for award for the above referenced RPQ based on your Price Quotation submitted on Wednesday, September 18, 2013. The total RPQ amount is for two hundred three thousand eight hundred ninety-eight dollars and seven cents (\$203,898.07). This includes a base contract amount of one hundred seventy-five thousand ninety dollars and six cents (\$175,090.06), a contingency amount of seventeen thousand five hundred nine dollars and one cent (\$17,509.01), and dedicated allowances totaling eleven thousand two hundred ninety-nine dollars and zero cents (\$11,299.00). The contract duration is established as **240-calendar days**. However, the recommendation of award is contingent upon the submission of the required items listed below:

1. Performance and Payment Bond as required in Contract No. MCC 7040 Plan, Section 2.0 Special Conditions, Page 16, Article 2.11, **PERFORMANCE AND PAYMENT BOND**. (The **original attached documents** must be used and three (3) sets must be provided).
2. Letter from Bonding Agent granting Miami-Dade County authorization to date the Performance Bond.
3. Copies of current insurance certificates.
4. Copies of required license(s).

The preceding documents are required as outlined within Contract MCC 7040 Plan and to be submitted within 10 business days. Failure to submit the document(s) within the specified time, or any extension granted, will result in the award being rescinded.

Subsequent to the review and approval of the aforementioned documents, you are required to obtain the required permits in the time stipulated in the RPQ. Upon obtaining the permit(s), a copy(s) must be submitted to the Project Manager prior to commencement of work.

No work is to be performed without a permit unless the Project Manager issues a written directive to proceed without permit(s).



Please be advised that your firm must have the resources to ensure work proceeds without delay once the "Notice to Proceed" is issued. Lack of equipment, personnel or additional contracts with similar completion schedules, will not be reason for delay.

Further, it shall be understood that since proceeds from the Charter County Transportation System Sales Surtax levied pursuant to Section 29.121 of the Code of Miami-Dade County may be used to pay for all or some part of the cost of this contract, no award of this contract shall be effective and thereby give rise to a contractual relationship with the County unless and until the Citizens' Independent Transportation Trust (CITT) and the County Commission have approved the award of the contract, and such award becomes final (either by expiration of 10 days after such award without veto by the Mayor, or by Commission override of a veto).


