RESOLUTION NO. _____

RESOLUTION DIRECTING THE COUNTY MAYOR OR MAYOR'S DESIGNEE TO TAKE APPROPRIATE ENFORCEMENT ACTION PURSUANT TO THE JUNK DEALERS AND SCRAP METAL PROCESSORS ORDINANCE PREVIOUSLY APPROVED BY THIS BOARD; FURTHER DIRECTING THE COUNTY MAYOR OR MAYOR'S DESIGNEE TO PROVIDE REPORTS

WHEREAS, on April 4, 2011, the Board of County Commissioners enacted Ordinance No. 11-17, the Junk Dealers and Scrap Metal Processors Ordinance, codified at Section 8A-9 of the Code of Miami-Dade County; and

WHEREAS, the purpose of the Junk Dealers and Scrap Metal Processors Ordinance is to protect the public health, safety and welfare by impeding the sale of stolen regulated metals property and thereby deterring the theft of regulated metals property in the incorporated and unincorporated areas of Miami-Dade County; and

WHEREAS, the Junk Dealers and Scrap Metal Processors Ordinance provides a minimum standard of recordkeeping that requires a legible record of all purchase transactions to which a junk dealer or scrap metal processor is a party; and

WHEREAS, the Junk Dealers and Scrap Metal Processors Ordinance further requires all records to be maintained for a minimum of five years and at all reasonable times be subject to inspection by any local law enforcement officer commissioned in the State and the Miami-Dade Inspector General's Office; and

WHEREAS, the Junk Dealers and Scrap Metal Processors Ordinance provides criminal penalties of up to 60 days imprisonment and up to a \$500 fine upon conviction and civil

penalties of up to \$1000 for every individual violation of the ordinance's recordkeeping provisions; and

WHEREAS, there have been reports that there are Junk Dealers and Scrap Metal Processors who are not complying with the Junk Dealers and Scrap Metal Processors Ordinance; and

WHEREAS, Junk Dealers and Scrap Metal Processors who are complying with the law are being placed at a disadvantage to those businesses that are not complying with the law; and

WHEREAS, section 8A-9.2(d) provides that the Miami-Dade Police Department shall provide a report annually to the Board on compliance with and enforcement of the Junk Dealers and Scrap Metal Processors Ordinance; and

WHEREAS, this Board would like to direct the County Mayor or Mayor's designee to take appropriate enforcement action based on the Junk Dealers and Scrap Metal Processors Ordinance previously approved by this Board, and to provide periodic reports to the Board on enforcement actions that are taken,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Directs the County Mayor or Mayor's designee to take appropriate enforcement action pursuant to the Junk Dealers and Scrap Metal Processors Ordinance previously approved by this Board.

Section 2. Directs the County Mayor or Mayor's designee to provide a report to the Board within 60 days of the effective date of this resolution on enforcement actions that have been taken, and to provide annual reports as required by the Junk Dealers and Scrap Metal Processors Ordinance.

The Prime Sponsor of the foregoing resolution is Commissioner Audrey M. Edmonson.
