

RESOLUTION NAMING THE PUBLIC HEALTH TRUST'S  
JACKSON SOUTH COMMUNITY HOSPITAL MAIN LOBBY  
"THE AMADEO LOPEZ-CASTRO, JR. MAIN LOBBY"

**WHEREAS**, Mr. Amadeo Lopez-Castro, Jr. who passed away on October 29, 2010, was an accomplished engineer and banker who served as a loyal and dedicated member of the Board of Trustees of the Public Health Trust; and

**WHEREAS**, Mr. Lopez-Castro, Jr. joined the Trust Board in 1994 and went on to serve as its Chairman from 2000 to 2002; and

**WHEREAS**, Mr. Lopez-Castro, Jr. firmly believed in providing world class care to all residents of Miami-Dade County; and

**WHEREAS**, Mr. Lopez-Castro, Jr. understood the irreplaceable role of the Public Health Trust and its mission in this community; and

**WHEREAS**, during his Chairmanship, Mr. Lopez-Castro, Jr. passionately advocated for the Public Health Trust's acquisition of the facility that is now known as Jackson South Community Hospital; and

**WHEREAS**, this Board desires to recognize the contributions Mr. Lopez-Castro, Jr. made to the Public Health Trust and the Miami-Dade County community by naming the Jackson South Community Hospital main lobby "The Amadeo Lopez-Castro, Jr. Main Lobby"; and

**WHEREAS**, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding proposed naming, renaming or codesignation of Miami-Dade County facilities or property shall be sponsored by the district commissioner where the facility or property is located; and

**WHEREAS**, the facility to be named is located in County Commission District Eight,  
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Having considered this matter at a public hearing, names the Public Health Trust’s Jackson South Community Hospital main lobby “The Amadeo Lopez-Castro, Jr. Main Lobby”.

**Section 2.** Directs the Public Health Trust of Miami-Dade County to revise all references to the Jackson South Community Hospital main lobby to “The Amadeo Lopez-Castro, Jr. Main Lobby” and to install suitable signage reflecting the new name.

The Co-Prime Sponsors of the foregoing resolution are Vice Chair Lynda Bell and Senator Javier D. Souto. It was offered by Commissioner \_\_\_\_\_, who moved its adoption. The motion was seconded by Commissioner \_\_\_\_\_ and upon being put to a vote, the vote was as follows:
