Subject: Setting of Proposed FY 2014-15 Countywide Voter-Approved Debt Millage Rate

Recommendation

It is recommended that the Board approve the Countywide voter-approved millage rate of 0.45 mills, as proposed in my FY 2014-15 Proposed Budget, for use in preparing the "Notice of Proposed Property Taxes" to be mailed to all property owners in August.

Scope

State law requires that all property owners be advised of proposed property taxes along with notification of public budget hearings. The Property Appraiser will mail required notices to all property owners in August using proposed tax rates adopted by all taxing authorities in Miami-Dade County.

Fiscal Impact/Funding Source

The millage rate recommended will generate \$90 million to support debt service payments for Countywide voter-approved debt.

Track Record/Monitor

Not applicable.

Background

The recommended Countywide voter-approved debt millage rate of 0.45 provides revenue to support the Building Better Communities General Obligation Bond (GOB) Program (0.422 mills) and the newly approved Public Health Trust GOB Program (0.028 mills) as provided for in the FY 2014-15 Proposed Budget.

RESOLUTION SETTING THE PROPOSED FY 2014-15
COUNTYWIDE DEBT SERVICE MILLAGE RATE

WHEREAS, Section 200.065, Florida Statutes, requires that within 35 days of certification of value each taxing authority advise the property appraiser of its proposed millage rate and rolled-back rate and of the date, time and place at which a public hearing will be held to consider the proposed millage rates and tentative budget so that the information can be included in the notice of proposed property taxes mailed to property owners in August and also establishes and describes the requirement that the governing body of each taxing authority hold public hearings on the tentative budget and proposed millage rates,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the proposed FY 2014-15 Countywide debt service millage rate equal to 0.4500 is approved for transmittal to the Property Appraiser.
