RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE APRIL 6, 2014 "IMMIGRATION REFORM" EVENT SPONSORED BY FRANCISCO MORAZAN HONDURAN INTEGRATED ORGANIZATION, INC. IN AN AMOUNT NOT TO EXCEED \$1,750.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 5 FY 2013-14 IN-KIND RESERVE FUND

WHEREAS, the Francisco Morazan Honduran Integrated Organization, Inc. has requested in-kind services from the Parks, Recreation and Open Spaces Department for the April 6, 2014 "Immigration Reform" event in an amount not to exceed \$1,750.00 (see attached Fee Waiver/In-kind Service Application); and






