Subject: Resolution Authorizing Additional Time, Expenditure Authority, and Extending Prequalification Pool Contracts for Purchase of Goods and Services

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize time extensions for a contract and prequalification pool, and additional expenditure authority, with authority to exercise option-to-renew (OTR) periods, as described below and in more detail in the accompanying attachments.

Section 1 - Time and Expenditure Authority Increase

The items in this section will increase time and expenditure authority for contracts to continue purchasing goods and services. The additional expenditure authority is for goods and services allowed under the original terms and conditions of the contract, but for which the funding necessary requires Board authorization. The total additional expenditure amount requested for these contracts is \$1,653,000.

Item 1.1 – Laundry Services: Requests additional expenditure authority in the amount of \$122,000 to allow the Juvenile Services Department to continue purchasing commercial laundry services.

Item 1.2 – Forensic Casework for DNA Analysis: Extends this contract for an additional six months so the Miami-Dade Police Department may continue to purchase forensic testing services. The amount requested for the six-month extension is \$300,000.

Item 1.3 – Tires: Extends this contract for an additional four months so various County departments may continue to purchase tires for County-owned fleet. The amount requested for the four-month extension is \$1,231,000.

Section 2 - Prequalification Pool Extension

The items in this section extend prequalification pools established for the purchase of goods and services, and increase expenditure authority. The total additional expenditure amount requested for the prequalification pools is \$133,936,000.

Item 2.1 – Air Compressors, Parts, Accessories, Repairs - Prequalification: Requests additional expenditure authority in the amount of \$2,000,000 to allow the Water and Sewer Department (WASD) to purchase a replacement 2,000-horsepower air compressor that has reached the end of its useful life for the South District Wastewater Treatment Plant

Item 2.2 – Veterinary & Pharmaceutical Supplies - Prequalification: Requests additional expenditure authority in the amount of \$2,250,000 to allow the Animal Services Department to continue purchasing a variety of veterinary medical and pharmaceutical supplies.

Item 2.3 – Parts and Repair Services for Transit Buses and other Support Equipment - Prequalification: Extends this prequalification pool for an additional five years so Miami-Dade Transit and other County departments may continue to use this pool to purchase repair services, replacement parts, products and supplies for buses and support equipment. The amount requested for the five-year extension is \$112,686,000.

Item 2.4 – Pumps & Motors, Purchase, Repairs and Parts - Prequalification: Requests additional expenditure authority in the amount of \$12,000,000 to allow WASD to continue purchasing pumps, motors and related items.

Item 2.5 – Special Purpose Trucks - Prequalification: Extends this prequalification pool for an additional five years so the Internal Services Department may continue to use this pool to purchase special purpose trucks on behalf of various County departments on an as-needed basis. The amount requested for the five-year extension is \$5,000,000.

Scope

The impact of the items is countywide in nature.

Fiscal Impact/Funding Source

The allocations and funding sources, by department, is listed in the attached items.

Track Record/Monitor

There are no known performance/compliance issues with the vendors recommended for award in this package. Each department's contract manager is reflected in the attached items.

Delegated Authority

If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise all provisions of the contracts, Section 2-8.1 of the County Code and Implementing Order 3-38.

Additionally, upon approval of the item in Section 2, vendors will continue to participate in spot market competitions. The County Mayor or the County Mayor's designee will have the authority to solicit pricing and award contracts up to an aggregate contract amount of the allocation authorized by the Board. The County Mayor or the County Mayor's designee may also add qualified vendors to the pool at any time during the term of the contract, subject to bi-annual ratification by the Board.


Due Diligence

RESOLUTION AUTHORIZING ADDITIONAL TIME AND EXPENDITURE AUTHORITY IN A TOTAL AMOUNT UP TO \$1,653,000.00 FOR CONTRACTS TO PURCHASE LAUNDRY SERVICES; FORENSIC CASEWORK FOR DNA ANALYSIS; AND TIRES; AND ADDITIONAL TIME AND EXPENDITURE AUTHORITY IN A TOTAL AMOUNT UP TO \$133,936,000.00 FOR PREQUALIFICATION POOL CONTRACTS TO PURCHASE AIR COMPRESSORS, PARTS AND ACCESSORIES; VETERINARY AND PHARMACEUTICAL SUPPLIES; PARTS AND REPAIR SERVICES FOR TRANSIT BUSES AND OTHER SUPPORT EQUIPMENT; PUMPS AND MOTORS; AND SPECIALTY PURPOSE TRUCKS

WHEREAS, the County Mayor recommends to this Board to authorize additional expenditure authority for the purchase of goods and services,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board authorizes additional time and expenditure authority as set forth in items 1.1 through 1.3 of the incorporated memorandum in an amount up to \$1,653,000.00 for contracts to purchase laundry services; forensic casework for DNA analysis; and tires.

Section 2. This Board authorizes additional time and expenditure authority as set forth in items 2.1 through 2.5 of the incorporated memorandum in an amount up to \$133,936,000.00 for prequalification pools to purchase air compressors, parts and accessories; veterinary and pharmaceutical supplies; parts and repair services for Transit buses and other support equipment; pumps and motors; and specialty purpose trucks.

Section 3. This Board authorizes the County Mayor or County Mayor's designee to execute contracts for the items approved herein and exercise all provisions of the contracts contained therein in accordance with the terms and conditions of such contracts, Section 2-8.1 of the County Code, and Implementing Order 3-38.

Section 4. This Board authorizes the County Mayor or County Mayor's designee to conduct spot bids, award subsequent contracts, and add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis, for the pools set forth in items 2.1 through 2.5 of the incorporated memorandum.



Contract Description and Reason for Change:
 Authorization is requested to increase expenditure authority of this contract by \$122,000 to allow the Juvenile Services Department (JSD) to continue purchasing commercial laundry services. More specifically, JSD uses this contract for the commercial laundering of arrestees' jumpsuits and blankets on a fixed schedule. The service is essential for the department as it has no other means for laundering these items. This increase reflects JSD's estimated usage for the full term of the contract.

JSD was recently added to this contract with an allocation for only a one-year period. The requested increase in expenditure authority will fund the department's needs for the remaining four years of the contract.

Contract Description and Reason for Change:
 Authorization is requested to modify this contract for additional time and expenditure authority to allow the Miami-Dade Police Department (MDPD) to continue to utilize this contract for forensic testing services. The MDPD Crime Laboratory utilizes the services of commercial laboratories in order to outsource forensic Deoxyribonucleic Acid (DNA) casework. Outsourcing these cases expedites the analysis of DNA evidence and reduces the time required to identify suspects and provide investigative leads through matches from the DNA database. The outsourcing effort reduces the number of cases pending analysis, and enables MDPD to focus on in-house DNA analysis for current crimes.

The replacement solicitation for these services is being advertised and the resultant contract(s) is expected to be awarded in early 2015. This extension will ensure continuity of services until the successor award is approved by the Board of County Commissioners.

Contract Description and Reason for Change:

Authorization is requested to modify this contract for additional expenditure authority to enable the Water and Sewer Department (WASD) to purchase a replacement 2,000 horsepower air compressor for WASD's South District Wastewater Treatment Plant. This plant processes the wastewater from about 1.1 million customers daily. The treatment process must meet stringent permit limits for the effluent, and uses pure oxygen to achieve the permit compliance. The pure oxygen is generated at the plant by compressing large volumes of air. The existing compressor has been in continuous services for nearly 30 years, and is increasingly unreliable which renders oxygen production sporadic rather than continuous. The acquisition of the new air compressor will enable WASD to improve process reliability, increase oxygen production to meet the population's requirements and increased permit compliance.

Contract Description and Reason for Change:
 Authorization is requested to modify this contract for additional expenditure authority to enable the Animal Services Department (ASD) to continue purchasing a variety of veterinary medical and pharmaceutical supplies and related emergency and miscellaneous items. The supplies and items include, but are not limited to, acepromazine, penicillamine, apomorphine, bladewash, cotton rolls, gloves, I.D. bands, and dexalyte.

ASD's medical and surgical needs have expanded over the last year and a half due to the implementation of the No-Kill initiative. During this period, the number of surgeries has increased from 10,707 to 16,341, representing a 53 percent increase. In addition to the increase in number of surgeries, the No-Kill initiative incorporates various new treatment and disease prevention programs to deter the spread of disease, as well as improve the medical care of injured and sick animals housed at ASD shelters. The requested increase is as a result of the increase in surgeries and disease preventions programs, as well as covers the department's needs throughout the remainder of the contract term that were underestimated in the existing allocation.

Contract Description and Reason for Change:

Authorization is requested to extend this existing pre-qualification pool for an additional five years to allow Miami-Dade Transit (MDT) and other County departments to continue purchasing replacement parts, components, supplies and repair services for engines, brakes, exhaust systems, transmissions, suspensions and air conditioners on buses and support equipment.

The value of the five-year extension of this pool contract is based on current and anticipated usage during the five-year extension period requested. The initial pool was established with eight vendors. Vendors that meet the pool requirements may be added to the pool at any time, subject to bi-annual ratification by the Board of County Commissioners. In the ensuing years after award of the pool contract, 55 vendors have met the minimum requirements and have been added to the pool. Pre-qualified vendors participate in spot market purchases as required by County departments on either an as needed or on a periodic basis.

The requirements, terms and conditions of the pool will not change if a replacement contract is issued, and it is anticipated that the same vendors will pre-qualify for a replacement solicitation. This pre-qualification pool will remain advertised on the County's Procurement Management Services website to encourage additional participation. As such, it is in the best interest of the County to modify the existing pool for an additional five year period to allow MDT and other departments to continue accessing this contract.
