**SUBJECT: RESOLUTION APPROVING THE RE-APPOINTMENT OF STUART BLUMBERG, WILLIAM PERRY, III, AND T. GENE PRESCOTT AND THE APPOINTMENT OF MICKY STEINBERG, A TOTAL OF FOUR (4) MEMBERS TO THE TOURIST DEVELOPMENT COUNCIL**

Resolution No. R-636-14, adopted on July 1, 2014, requires the Office of the Commission Auditor (OCA) to complete background research on applicants being considered to serve on County Boards and Trusts that require nominations and/or appointments by the Board of County Commissioners (BCC).

In accordance with the Resolution, we are providing this report as a supplement to the BCC Agenda Item 8(C) 1.

Pursuant to R-636-14, the OCA completed background research regarding BCC Agenda Item 8(C) 1, Resolution approving the re-appointment of Stuart Blumberg, William Perry, III, and T. Gene Prescott and the appointment of Micky Steinberg, a total of four (4) members to the Tourist Development Council.
