

RESOLUTION CODESIGNATING N.W. 66 STREET FROM
N.W. 17 AVENUE TO N.W. 19 AVENUE AS "HAROLD I.
SANDILANDS STREET"

WHEREAS, Harold Sandilands was born on April 12, 1901 in the Bahamas and moved to Miami-Dade County in 1920, where he spent the remainder of his life; and

WHEREAS, Mr. Sandilands was a member of the Benevolent and Protective Order of Elks and served as Exalted Ruler of the Liberty Elks Lodge #1052, which is located at 6525 NW 18 Avenue, Miami, FL 33147; and

WHEREAS, under his leadership, the Liberty Elks Lodge #1052 provided excellent community service throughout Miami-Dade County, including holding food drives every weekend and supporting the Miami Northwestern Senior High School Marching Band's field trips; and

WHEREAS, he was a founding member of the Christian Fellowship Missionary Baptist Church and held the position of Chairman of the Trustees Board from 1971 until 1981; and

WHEREAS, Mr. Sandilands passed away at age 82 on May 27, 1983; and

WHEREAS, this Board would like to recognize the memory of Harold Sandilands and his contributions to this community by codesignating N.W. 66 Street from N.W. 17 Avenue to N.W. 19 Avenue adjacent to the Liberty Elks Lodge #1052 as "Harold I. Sandilands Street"; and

WHEREAS, N.W. 66 Street from N.W. 17 Avenue to N.W. 19 Avenue is a County road located within unincorporated Miami-Dade County; and

WHEREAS, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding proposed codesignations of Miami-Dade County roads shall be sponsored by the district commissioner where the road is located; and

WHEREAS, this codesignation is located in County Commission District 3,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, codesignates N.W. 66 Street from N.W. 17 Avenue to N.W. 19 Avenue as "Harold I. Sandilands Street."

Section 2. Directs the Clerk of the Board to send certified copies of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.
