

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE DECEMBER 7, 2013 "LA CRITERIA EN SWEETWATER HOLIDAY CELEBRATIONS" EVENT SPONSORED BY THE COMMUNITY PERFORMING ARTS ASSOCIATION, INC., IN AN AMOUNT NOT TO EXCEED \$340.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 12 FY 2013-14 IN-KIND RESERVE FUND


