It is recommended that the Board consider the appointment of Mr. Carlos Trujillo to serve as a member of the Public Health Trust (PHT) of Miami-Dade County – Jackson Health System.

Pursuant to Chapter 25A-3(d) of the Miami-Dade County Code, the Miami-Dade County Legislative Delegation has appointed Mr. Carlos Trujillo to the Public Health Trust. This seat became vacant upon the resignation of Representative Michael Bileca.

Chapter 25A of the code further provides "...upon receipt of any written designation to fill a designated vacancy by the Mayor or the Chairperson of the Miami-Dade County Legislative Delegation, the Clerk of the Commission shall serve copies on the Nominating Council. The Nominating Council shall conduct reference reviews and background screening for each designee. Upon completion, the Council shall submit the results to the Clerk of the Commission."


