RESOLUTION DESIGNATING COUNTY PARKS LIBRARIES AS CRIME-FREE AND DRUG-FREE ZONES, DIRECTING THE COUNTY MAYOR DESIGNEE TO INCREASE MIAMI-DADE COUNTY POLICE PRESENCE AND PATROLS AROUND COUNTY PARKS AND URGING LIBRARIES, AND MUNICIPALITIES COUNTY PARKS OR LIBRARIES WITHIN BOUNDARIES TO INCREASE POLICE PRESENCE AND PATROLS AROUND COUNTY PARKS AND LIBRARIES

WHEREAS, County parks and libraries are intended to be safe havens for children, the elderly, families and all County residents alike; and

WHEREAS, people visit County parks and libraries seeking wholesome and secure recreational, educational, meeting, and entertaining activities and spaces; and

WHEREAS, yet, illegal activities such as drug sales, theft, assault, batteries and other violent crimes continue to occur at our County parks and libraries putting in peril these community safe havens and those who visit them; and

WHEREAS, this Board has zero tolerance for drugs or crimes in our parks and libraries and desires to see increased police presence and patrolling at these County facilities in order to provide visitors with increased security and sense of safety, to deter drugs and crime at these County facilities and, to the extent that there is any crime occurring or drugs present at these County facilities, to quickly respond to such activities and apprehend the perpetrators,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby designates County parks and libraries as crime-free and drug-free zones. This Board further directs the County Mayor or Mayor's designee to increase Miami-Dade County Police presence and patrols around County parks and libraries and urges municipalities with County parks and

libraries within their municipal boundaries to increase police presence and patrols around those County parks and libraries, all in an effort to provide visitors with increased security and to decrease and ultimately eliminate crime and drugs in parks and libraries.
