SUBJECT: RESOLUTION DESIGNATING AS "COUNTRY CLUB LAKES" A PORTION OF THE UNINCORPORATED AREA IN NORTHWEST MIAMI-DADE COUNTY THAT IS BOUNDED ON THE NORTH BY THE BROWARD COUNTY LINE, ON THE SOUTH BY THE PALMETTO EXPRESSWAY, ON THE EAST BY NORTHWEST 47th AVENUE, AND ON THE WEST BY NORTHWEST 67th AVENUE FROM THE PALMETTO EXPRESSWAY TO NORTHWEST 186 STREET AND THE CANAL DIRECTLY EAST OF NORTHWEST 77 COURT FROM NORTHWEST 186 STREET TO THE BROWARD COUNTY LINE

Ordinance No. 13-29, adopted on April 2, 2013, requires the Office of the Commission Auditor (OCA) to complete background research on any person, organization, place or thing that is the subject of a naming, renaming or codesignation item.

In accordance with the Ordinance, we are providing this report as a supplement to the Board of County Commissioners (BCC) Agenda Item 5(A).

Pursuant to Ordinance No. 13-29, the OCA completed background research regarding BCC Agenda Item 5(A), Resolution designating as "Country Club Lakes" a portion of the unincorporated area in Northwest Miami-Dade County that is bounded on the north by the Broward County Line, on the south by the Palmetto Expressway, on the east by Northwest 47th Avenue, and on the west by Northwest 67th Avenue from the Palmetto Expressway to Northwest 186 Street and the canal directly east of Northwest 77 Court from Northwest 186 Street to the Broward County Line, and there were no adverse findings.
